


Section 7.1

The Ridgely/Bowman farmhouse was originally a log structure built in 1825, however in 1890 Victorian elements were added such a transom, tripartite bay, and fishscale shingles. In 1963 a two-story lean-to addition was constructed on the northwest facade. The building elements are a combination of materials, such as the original log construction on a stone foundation, the Victorian frame construction on a stone foundation, and the shed roof frame addition on a brick foundation. The farmhouse is in excellent condition, with vegetation kept back from the foundation except for small hedges. The other farm buildings, such as the water tower, bank barn, corn crib, and sheds, are used for storage and are in good condition.



DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ridgely/Bowman house is a circa 1825 two-story, German-sided-over-log structure with a circa 1890 taller two-story clapboard wing constructed perpendicularly to the older section. The over-all plan is a T-shaped one.

The log section is three bays wide and one bay deep with its principle facade facing southeast. The first story of this facade is distinguished by a central doorway flanked by louvered, shuttered windows with 6/6 sash. Two identical windows define the window openings of the second story. An internal, corbel capped brick chimney is found in the northeast gable end. Cornerboards, a boxed cornice and a standing seam tin roof further articulate this wing.

Photographs taken prior to the building's 1963 rehabilitation indicate that a porch once spanned this facade. The window sash was 2/2. More than likely these features were later improvements to the log structure.

A similar porch ran across the rear northwest facade. This facade is now obscured by the 1963 two-story-lean-to addition. This wing is of clapboard construction. A first-storey entrance is located in the southern bay. Smaller 6/6 sashed windows define the northern bay as well as the two similar openings of the second story.

Originally the interior was partitioned into two rooms, the kitchen and the living quarters. A winder stairs located led to a loft sleeping area. The log section is now a single room both up and down.

The Victorian wing is also three bays wide and one bay deep. Its principle facade faces southwest. This facade is distinguished by a central doorway flanked by windows with 6/6 sash. The doorway has a simple three light transom; the windows have louvered shutters. Three identical windows define the second storey openings. An open porch with simple 4x4 timber supports spans the first story. A corbel capped brick chimney is centrally located in this section. The roof is of standing seam tin.

Pre-renovation photographs show that this wing originally had double interior brick chimneys, 2/2 sashed windows and the porch supports were columnar, resting on high brick piers. The 2/2 sashed windows and double chimneys probably were original to the wing. The porch however could have been a later addition.

STATEMENT OF SIGNIFICANCE

The Ridgely/Bowman House well illustrates the history of vernacular building techniques in Howard County in the nineteenth and early twentieth centuries. The oldest section of the farmhouse is a modest two storey log structure which, like most log buildings in the county has been "improved" by the addition of clapboards. This method of construction continued into the twentieth century examples such as the George Willson Log House and Walter Belt Log House also within Patuxent State Park attest to this fact.

In the second half of the nineteenth century these log structures easily accommodated various additions. The taller two-storey clapboard wing of the Ridgely/Bowman House characterized a need for more space as well as an indication that its builder was aware of and could afford current stylistic trends in building. The Bowman wing with its tripartite bay on the south east facade displaying a pedimented bable with fishscale shingles is a good example of rural victorian architecture.

Although it is unclear who actually built the log section of the house according to a 1840's equity case between heirs of Philemon S. Ridgely and Henry Welling two structures, a house and a tenement existed on the property. The heirs of Ridgely claimed that their father sold the land to Henry Welling for the uses, intents, and purposes "in trust for the legitimate children of said Philemon S. Ridgely as the said Henry Welling may think proper for the use of them and their heirs." They further contended that Welling received the land, held possession of it and "regularly took rents and profits and enjoyed the entire use there of...and[refused] to give up the possession there of...also said Welling [had] totally mismanaged the said premise..."

The defendant, Henry Welling answered the charge claiming that Philemon Ridgely was in debt and that was the reason that this parcel was put into trust so that his debtors would be satisfied. Welling claimed that Ridgely and his family remained on the premise until the fall of 1825 and during that time Ridgely applied the rents and profits to the support of his family. Dennis Ridgely [presumably his son] was permitted to occupy the nearby small tenement and cultivate the small lot surrounding it. Con-

Page 2 Description Ridgely/Bowman House

The southeast facade is a tripartite bay with 6/6 sashed windows in each of the three openings of both stories. Louvered-shutters flank all six windows. The attic level is pedimented with two small windows centrally located. Fishscale shingles further accentuate this area. Early photographs show a similar window arrangement except that the window sash is 1/1 rather than 6/6.

The northwest facade yields a much less decorated design. Windows with 6/6 sash are centrally located on both stories. A smaller 6/6 window is found at the attic level. A box cornice with heavy cornice returns further distinguishes this facade. A bulkhead is located in the northern bay.

The interior of this section holds a very symmetrical arrangement as suggested by its exterior articulation. A center hall flanked by double parlors defined the first story. A central stairway leads to the two upstairs bedrooms, directly above the parlors. Access between the log and frame wings is located on the first storey. Various outbuildings surround the farmhouse including a one-story clapboard smokehouse which was converted in 1963 to a small guest house.

cluding his defense Welling said that it was Ridgely and his heirs who mismanaged and ignored the land.

Welling died before the court issued its decision that the heirs of Welling were to sell the property to the heirs of Ridgely. (See Equity Records B166-142)

In any case this equity dispute indicates that two structures were on the property in 1825. The Ridgely heirs sold the 23 3/4 acre parcel to James Parker who four years later in 1856 sold the same land to George Ellicott. The Martenet and Bond 1862 Map of Montgomery County lists George Ellicott as the owner of a farm in this general area. Undoubtedly Ellicott rented this farm to a local farmer for he and his wife Agnes were involved in the milling industry near Ellicott City at this time.

Ellicott sold the farm to a Dennis Collins for \$250.00. Both Collins and his wife are buried nearby in a 20'x15' garden. This tiny parcel of land is exempted from most of the subsequent deeds.

After a series of short term owners the Bowman family acquired the 23 3/4 acre farm as well as a series of continous parcels of land which totaled 188 in 1912. It remained in the Bowman family in the 1940's.

The final owner of the farm prior to state aquisation in 1972 was Paula McDonald ABB. From 1963-1972 ABB completely renovated the structure which had fallen into considerable disrepair.

The house is now occupied by Patuxent State Park personnel.

RECOMMENDATION


The Ridgely/Bowman House should be returned to private ownership with the appropriate measures taken to insure that proper restrictions are attached to the deed.
