This house is located on .5 acres on the west side of N. Rogers Avenue between I-70 and Old Frederick Road. One of a collection of five late-Victorian eaves-front with center gable houses on the block, it has a shallow setback from the road aligned with the others along the street in the pattern of small town.

Built about 1910, the 2 1/2 story frame house is typical of the mid-Atlantic vernacular architecture defined by its prominent center gable. An I-house in form with a center hall plan, the structure is three bays long by one bay wide with a two by one bay ell. A full width porch extends along the facade. It has turned columns with brackets decorated with clover shaped designs. The balustrade is embellished with "X" patterns surrounding a bullseye. The porch floor is tongue and groove board. The windows are symmetrically arranged and are double-hung 2/2 sash with shutters. There is a pair of windows in the center gable. Two slender brick chimneys protrude from the roof ridge on either side of the center gable. There is also a small brick chimney on the gable ridge on the rear of the ell. The house is covered with a standing seam metal roof and it has a fieldstone foundation.

A one-story L-shaped frame wing was added to the north side of the house during the 1970s and asbestos siding was added over the clapboards, but neither addition detracts from the integrity of the structure.

Significance Statement Continued

An I-house, it is one of four early 20th century examples of late Victorian vernacular styles, with prominent center gables that line North Rogers Avenue.

A total of seven houses line the 2800 block off of North Rogers Avenue. Cut off from Rogers Avenue when I-70 was built in the 1950s, the houses reflect a turn of the century environment. Only one house on the block was built after World War II.


This house and its neighbors represent a suburban style of development in an area previously dominated by farms. These houses are still in a traditional farmhouse form arranged in a pattern different from early Jonestown houses which were scattered around farms with no apparent relationship to the road. The half dozen turn of the century houses along this section of Rogers Avenue were arranged in a row facing the street and were evenly spaced behind a row of trees. By 1910, the section of the avenue that for 50 years had only two churches along it, looked like a traditional "Main Street."

This small development reflects a significant economic shift in an area dominated by farming for well over a century. Although many large farms are still in operation in the Jonestown area, by 1900 families were building larger houses on smaller lots, indicating that residents were involved in other occupations and were commuting to work rather than tending fields nearby. Although dwarfed next to nearby Ellicott City, the tiny community of Jonestown (later called Rockland) was essentially self-sufficient until the mid 20th century with two grocery stores, two churches, a school and a dance hall.

The earliest deed reference to the property involved a transaction between Rezin Jones, the major property owner in the area and after whom the town was named, sold a 7 acre parcel to Sam Burgess. In 1895 Burgess sold the land to August Stirn and for the next 75 years the property was bought and sold among members of the Tucker and Stirn families. The Stirns and the Tuckers had been major landholders in the northeast section of Rogers Avenue since the mid 1800s. Members of those families ran large farms in the area until the 1970s. In 1954 the State Roads Commission acquired 6.5 acres of the lot for the Rogers Avenue realignment.

The house is currently in excellent condition and retains its historic character.
