Based on the available information, the Warfield-Sullivan House, located at 3625 MD 32, near the town of West Friendship in Howard County, does not appear to meet the National Register Criteria for individual listing. The property includes a frame and log house, barn, machine shed and smokehouse. Although the house (c. 1870 and c. 1903) is noteworthy for its architectural detailing, including a projecting bay with tripartite window and decorative shingles, the house does not appear to possess sufficient architectural significance to warrant listing under Criterion C. In addition, the integrity of the house has been compromised by a series of additions and interior remodeling. The only historic agricultural building is the barn, which probably dates to the early twentieth century. The barn is a modest example of an extremely common type, with no particular architectural significance. The property has no known association with any significant event or person. It is not located in any known historic district.

The Warfield - Sullivan House is located on the east side of MD 32 in a rapidly developing part of Howard County near the intersections of Burnt Woods, Pfefferkorn and Ivory Roads with MD 32. The property is located below the grade of Md 32 (on the west) and is accessed by means of a short segment of the former Ivory Road.

The roughly 50 acre property is the location of four buildings plus a small mobile home which were constructed and/or evolved in three distinct periods. The original log portion of the dwelling and the barn probably date to the late nineteenth century ownership of Thomas Warfield. The additions to the dwelling, including a room west of the original log section and a two-and-one-half story frame addition on the west end, date to the early days of the Sullivan ownership, ca. 1903. In the last fifty years a smokehouse and equipment shed were constructed, and/or numerous additions and remodeling have occurred with both the dwelling and the barn. A metal house trailer was also moved to the property during that time.

The dwelling is a very large frame, ell shaped structure which assumed its present size and configuration as a result of numerous enlargements and modifications which have occurred in the last 125 years since the initial construction of a very small, probable one and one-half story structure in ca. 1870 during the time it was owned by Thomas Warfield. This log section constitutes the rear on back (east) room of the ell. Its log construction was only recently revealed when the siding was removed on the south (originally the principal) elevation (under an enclosed porch), according to the owner. This portion of the structure had evidently been raised at one point, with the upper section constructed of regular stud walls. This log core was expanded to the west with a 15X16 foot frame section (the door between them has been removed). This room, heavily modified, is currently utilized as a dining room. A screened, one story, shed roofed porch spans the entire south elevation of these two sections.

A large frame addition placed perpendicular to the original part of the structure was constructed by Nelson and Emilie Sullivan in 1903. Facing west toward Ivory Road, it is three bays wide and one bay deep, with the formal entrance centered in a projecting bay which, carried through into the interior, constitutes the foyer of the structure. Diagonally placed doorways access the two principal rooms. This section, two-rooms up and two rooms down, was greatly expanded to the north in 1982 with a one-story, gable roofed section, doubling the size of the parlor. This extensive building program, lasting five years and undertaken by the current owner, included adding a deep, shed roofed, one story tall kitchen along the entire north face of the ell, building a stair to the attic and undertaking major remodeling of the interior spaces. The exterior was sheathed with vinyl and many windows were replaced.

Also located on the property are a frame machine shed (off the northwest corner of the house), and a smokehouse, plus a barn, both of the latter north of the house. Of these three outbuildings, only the barn pre-dates 1956, and it was recently expanded by the current owner with the construction of a loafing shed in 1965 and other modifications. This frame barn, with a hay door located at the peak of the east gable end, was extended on the rear (west) and side (north) with one story, shed roof outshuts. The exterior is sheathed with vertical board siding.

The dwelling is the most significant of the structures on the property. Although much of the original exterior and interior fabric has been removed and/or sheathed, the exterior is still noteworthy for its projecting bay, topped by a cross gable with a round headed window near the peak. The gable end is sheathed with wood shingles and a variety of patterns. This is the only original external wall sheathing to remain in situ. A tripartite window is located in the second level. The front door, in the center of the bay, is sheltered by a full width pyramidal roof carried on lathe turned posts atop wood plinthes.



The Warfield - Sullivan property is the location of four structures and a mobile home which comprise a modest homestead on a roughly forty-seven acre parcel used primarily for horse pasture. It has minor significance as a representative late nineteenth and early twentieth century property which resulted from periods of expansion and alteration during the tenure of a succession of owners. The only structure with any noteworthy architectural features is the much modified early twentieth century frame section on the east. Although the complex has some connection to large, Howard County families because of its brief ownership by minor members of the Warfield and Selby families, the association is not strong enough to warrant inclusion in the National Register. The property was the location of a small forty acre farm purchased and possibly built by Enoch Selby for his son Thomas on an out parcel of the larger Dorsey estate. Selby sold it to the Sullivans in 1901.

Although the complex retains some integrity of location setting, design, feeling and association, the material integrity of the dwelling has been greatly compromised by the extensive renovation of the interior and numerous additions to the structure. Thus the property is only moderately significant for the architectural character of the early twentieth century addition to the dwelling.
