The house and associated buildings at 8377 Old Columbia Road are not eligible due to the fact that ~~it does~~ ^{They DO} not meet National Register Criteria A, B, C, or D. Preliminary research has not revealed any association between the dwelling and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in our past (Criterion B). Although the building provides an example of the Craftsman-Bungalow style, it is neither unusual nor distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). There is no evidence that the property is likely to yield information important in history or prehistory (Criterion D). Thus, the property is not National Register-eligible.

CAPSULE SUMMARY
8377 Old Columbia Road
(HO-697)

Erected in 1930, the 1-1/2-story, wood frame house at 8377 Old Columbia Road is designed as a Craftsman-style Bungalow. The house, rectangular in plan, is set on a parged solid concrete foundation. The walls are now clad in vinyl siding, but original wood shingles remain in the gable end walls. The asphalt shingle side gable roof is pierced at the front and rear by large gable roof dormers. Typical of the Craftsman style are the full-width porch supported by brick piers and tapered, dwarf posts, grouped windows, and wide overhanging eaves. The rear porch, originally open underneath the rear slope of the roof, has been enclosed with vinyl siding.

Howard Robinson acquired four lots of land amounting to 40.5 acres from his relative, Laurence Robinson, in 1930. In 1937, he sold the house along with 6.99 acres to William J. and Ethel L. Dustin, Jr. The Dustins continued to own the house along with just under seven acres for thirty years until 1967. At that time they sold 1.525 acres of land including the house to Stanley and Audrey V. Wojick in 1967. The property passed through the hands of one subsequent owner before the current owners, Joyce and David Stein, acquired the land in 1977.

Erected in 1930, the 1-1/2-story, wood frame house at 8377 Old Columbia Road is designed as a Craftsman-style Bungalow. The house, rectangular in plan, is set on a parged solid concrete foundation. The walls are now clad in vinyl siding, but original wood shingles remain in the gable end walls. The asphalt shingle side gable roof is pierced at the front and rear by large gable roof dormers. Typical of the Craftsman style are the full-width porch supported by brick piers and tapered, dwarf posts, grouped windows, and wide overhanging eaves. The rear porch, originally open underneath the rear slope of the roof, has been enclosed with vinyl siding.

Set on a large lot that slopes down to the southwest, the bungalow at 8377 Old Columbia Road is surrounded by several mature shade trees that screen it from the road. The house sits back approximately 40 feet from Old Columbia Road on its southeast side, and the property spans the distance between Old Columbia Road on the northeast and Route 29 to the southeast.

EXTERIOR DESCRIPTION:

The facade of the house at 8377 Old Columbia Road, the northwest elevation, is divided into three bays. A slightly off-center entrance filled with a single-leaf paneled door. To either side of the door is a pair of 3/1 wood sash windows. The front facing gable-roof dormer is pierced by two smaller wood sash windows with an identical light pattern. All openings are surrounded by square-edged casings.

The foundation wall of the southwest wall is pierced with two window openings, one filled with a single-light wood awning window and the other with a 3-light wood awning window. The southwest wall also holds three sets of paired 3/1, double-hung wood sash windows, two at the first story, and one set at the upper half-story.

At the rear, or southeast side of the building, the back wall of the enclosed porch is divided by three bays. One bay, farthest to the west contains a single 3/1, original wood sash window. The center bay is marked by a single leaf panel-and-light door. The eastern bay of the first story contains a bank of four two-light, fixed windows.

The foundation wall of the northeast elevation is pierced by one 3-light wood awning window and by a single paneled wood door set

below ground level. The first story of this elevation is divided into two bays, one containing a single, 3/1 window and the second a pair of the same windows. Another pair of the original 3/1 windows pierces the upper half story of the northeast wall.

OUTBUILDINGS:

In addition to the main dwelling, five related outbuildings occupy the rear of the property at 8377 Old Columbia Road. These include one historic garage converted into an office, two workshop buildings, a pre-fabricated garage, and a shed. The buildings are scattered to south of the dwelling.

The 1-1/2-story, wood frame historic garage is constructed of concrete block with asbestos shingles in the gable end. The building, originally constructed in the 1940s, has been converted into an office with the addition of a paneled wood door flanked by five-light sidelights and a projecting multi-light bay window on the front. The upper half story is lit by a single 6/6, double-hung wood sash window.

The northern workshop building, dating from the 1950s, consists of a one-story, wood frame building set on a concrete foundation and clad in plywood with battens. The asymmetrical side gable roof is covered in standing seam sheet metal and the walls are pierced with six-light metal awning windows.

Another workshop stands just southwest of the first and is set into a small slope. This 1960s concrete block building is one story in height with a flat, built-up roof.

Further southwest stand two 1970s prefabricated structures, one front gable metal garage with a overhead rolling door, and a small metal shed with a front gable roof.

The dwelling at 8377 Old Columbia Road is a good example of the Craftsman-style Bungalow that was popular in rural areas between the 1920s and 1940s. Built in 1930 for Howard M. Robinson, the house is one of several modest residences erected along this stretch of Old Columbia Road in the 1930s. The house displays distinct characteristics of the Bungalow form and Craftsman style including its compact rectangular footprint, prominent front porch and exaggerated tapered dwarf columns on the front porch. The wide eaves and large front and rear dormers are also typical of the style.

Howard Robinson acquired four lots of land amounting to 40.5 acres from his relative, Laurence Robinson, in 1930. In 1937, he sold the house along with 6.99 acres to William J. and Ethel L. Dustin, Jr. The Dustins continued to own the house along with just under seven acres for thirty years until 1967. At that time they sold 1.525 acres of land including the house to Stanley and Audrey V. Wojick in 1967. The property passed through the hands of one subsequent owner before the current owners, Joyce and David Stein, acquired the land in 1977.



RESOURCE SKETCH MAP
