The house at 10560 Shaker Drive is not eligible due to the fact that it does not meet National Register Criteria A, B, C, or D. Preliminary research has not revealed any association between the dwelling and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in our past (Criterion B). Vernacular in design, it is neither unusual nor distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). There is no evidence that the property is likely to yield information important in history or prehistory (Criterion D). Thus, the property is not National Register-eligible.

CAPSULE SUMMARY
10560 Shaker Drive
(HO-722)

The vernacular dwelling at 10560 Shaker Drive was erected at this site in the 1930s or early 1940s. One-and-one-half stories in height, the house is set on a solid parged concrete foundation, and the wood frame walls are clad in vinyl siding. A front gable roof, which is pierced by two gable wall dormers at the northwest elevation, covers the residence, and a one-story, one-bay porch with supports of cast brick extend across the facade. An exterior brick chimney laid in stretcher bond rises above the asphalt shingled roof.

The property at 10560 Shaker Drive was purchased by Theresa A. Weyrich and Mary E. Brown in January of 1931. During the period of joint ownership, which extended through 1945, a dwelling was constructed on the property. After the house was constructed, the property was sold to C. Ross and Sadie D. Ramsburg. The property has been owned by the Ramsburg family since 1945.

The dwelling at 10560 Shaker Drive was erected at this site in the 1930s or early 1940s.¹ One-and-one-half stories in height, the house is set on a solid parged concrete foundation, and the wood frame walls are clad in vinyl siding. A front gable roof, which is pierced by two gable wall dormers at the northwest elevation, covers the residence, and a one-story, one-bay porch with supports of cast brick extend across the facade. An exterior brick chimney laid in stretcher bond rises above the asphalt shingled roof.

The dwelling is sited twenty feet to the southeast of Shaker Drive, which parallels Columbia Pike. The house is surrounded by mature trees, including a Japanese Maple to the southeast. A wood fence defines the property boundary to the southwest. A driveway connecting the house to Shaker Drive runs to the southeast, past the main entrance on the southwest elevation.

EXTERIOR DESCRIPTION:

The southwest elevation, the facade of the house, is composed of the gable end wall and the one-story porch. Beneath the roof of the porch, the first story of the building is marked by a central entrance filled with a single leaf, panelled door. To either side of the doorway is a single 3/1 window. A single 3/1 window marks the upper half story at this elevation. All window and door surrounds are encased in aluminum.

The eastern portion of the southeast wall of the dwelling is obscured by a one-story extension with a shed roof. To the west of the extension is a 3/1 window. The extension itself is pierced by several openings at this elevation. On the southwest wall of the corner created by the intersection of the side wall of the dwelling and the extension is a 1/1 window. Within the southeast wall of the extension are a one-light window in the foundation wall and two

¹ According to the current owners, the Ramsburgs, this house was formerly Atholton School House, located on Columbia Pike. As a result of road work performed at Columbia Pike, the school house was reportedly moved to this location not long before the Ramsburgs moved to the house. According to the owners, evidence of the building's life as a school remains in the form of a teaching platform on the interior of the house. This however, was unable to be ascertained from the exterior of the house, and interior examination is recommended.

1/1 windows at the first story. With the exception of the window in the foundation, all openings are encased with aluminum surrounds.

The northeast elevation includes the rear gable end wall of the house, a one-story shed roof vestibule that obscures the western portion of this wall, and the side wall of the frame extension to the southeast. The first story is marked by a 1/1 window in the original gable end wall and by a 1/1 window in the northeast shed extension. The shed roof vestibule also holds several openings at the first story. At the southeast wall of the corner created by the intersection of the gable end wall and the vestibule is a single-leaf, panel-and-light door and a one-light awning window, and in the northeast elevation of the vestibule are four six-light awning windows. The upper half-story of the gable end wall is pierced by one 3/1 window. All opening surrounds are encased with aluminum.

The northwest elevation is composed of the side elevation of the front gable house and the side elevation of the vestibule extension at the rear. Within this elevation six sash windows are located at the first story, four 3/1 windows and two 1/1 windows. The upper half-story is marked by two gable wall dormers, each of which holds a 3/1 window. Again, all openings are surrounded with aluminum casings.

OUTBUILDINGS:

Two gambrel roof sheds with concrete foundations are located to the southeast of the main dwelling. One is a 1970s building with vinyl siding and the other is a 1980s structure with vertical board siding.

A small frame shed is located to the southeast of the main house. This 1980s gambrel roof shed has a concrete block foundation and vertical board siding.

A 1940s shed with German siding and a metal gable roof stands east of the main house. The building has a shed roof addition constructed of plywood.

A make-shift, sheet metal enclosure with a flat roof sits to the southeast of the main house.

The property at 10560 Shaker Drive was purchased by Theresa A. Weyrich and Mary E. Brown in January of 1931. During the period of joint ownership, a dwelling was constructed at this location. Following the erection of the house, the property was sold to C. Ross and Sadie D. Ramsburg, who purchased the land in 1945. The property has been owned by the Ramsburg family since that time. Typical of many of the houses erected in the Scaggsville area in this period, the dwelling reflects its rural roots by not following any particular style. Instead, the vernacular dwelling borrowed popular elements of the period including Revival-style gable wall dormers and a Craftsman-style porch.

Constructed in 1873, the Atholton School House was located in this area of Howard County along Columbia Pike. Oral history asserts that the school was active from the date of its construction until the late 1930s or early 1940s when the building was abandoned and reportedly moved to this site. Based on visual exterior inspection, this claim could not be confirmed.
