The Trust investigated the possibility of a rural historic district along Gorman Road and Murray Hill Road in the southeast section of Howard County. (See attached map.) Howard County has designated Gorman Road as a scenic road. It retains its original curvy alignment through an area predominately developed in the early twentieth century by wealthy families. While twentieth century properties exist along these roads, there is an equal amount of modern construction which greatly reduces the integrity of the historic landscape. For every property that is over fifty years old, there is a corresponding modern house c.1960s-1990s. A modern greenhouse business operates at 10010 Gorman Road. Although Gorman Road does retain its rural appearance and configuration, the modern construction along the road introduces visual elements which are out of character with the early twentieth century appearance of the landscape. There are properties along this alignment which may prove to be individually eligible such as Overlook Farm (HO-236) and Linden Manor/Locust Hill, the region as a whole has undergone too much change to constitute a rural historic district, based on existing, limited information.
