Near Worton Creek
mid-18th century

Buck Neck is the name of a tract patented in 1666 to Joseph Hopkins.¹ During the 18th century it appears to have been owned by two or three generations of the Graves family. It was resurveyed in 1737 for 493 acres for Sarah Graves, wife of William Graves.² Its position at the headwaters of Worton Creek was ideal for shipping since it was close to the Chesapeake Bay. In the mid-18th century it is known to have been the location of one of the county's tobacco warehouses.

Uphill from the landing stood one of the farmhouses which is mentioned in the 1783 Tax Assessment in the ownership of Richard Graves:

"Buck Neck 493 acres at @616.15

pt. Conny Warren 163 acres at @203.15

Prince Wm. 90 acres at @112.10

Pt. Doe Neck 27 acres at @33.15

Wye Hill Downs 50 acres at @62.10

Two Brick Dwelling Houses and one kitchen

Nine out houses and one barn

One young orchard and one old orchard"³

An old photograph of the house shows a three-bay, two-story whitewashed brick house with small kitchen and outbuilding. The overhanging roof of the kitchen is similar to the kitchen wing at Broadnox and Hinchingham.

In the early 1960's the area was developed into a housing development called Chesapeake Landing. Only the large frame barn remained and was initially used as a clubhouse for the residents.

SITE OF BUCK NECK
Worton, Maryland
(18th century)

On this site once stood one of Kent's 18th century farmhouses. An old photograph in the files of the Maryland Historical Trust shows that the building was two stories tall and three bays long. Its kitchen wing had an unusual overhanging roof similiar to that at Broadnox (K-98) near Rock Hall.

Buck Neck house was destroyed by fire. An existing photograph in the files of the Maryland Historical Trust was the basis of a report by Michael O. Bourne in 1968.

"One existing photo of Buck Neck shows that it was a 3 bay long, 2 story structure with a one story kitchen wing. Unusual is the overhang to the kitchen roof, like Broadnox, (K-98) also in Kent County.

The site is presently being developed for housing."

The only remaining farm building on Buck Neck is a large frame bank barn, now used as a club house.
