Partnership Farmhouse is significant because it typifies in form and plan the common central gable houses of this county. The floor plan with the secondary stair running parallel to the rear wall of the main house is one of two arrangements frequently used. The stair, trim, mantles, doors, sash, and other detail of the interior and exterior are seen again and again in buildings of ca 1870-1890. The builders of that time depended chiefly upon sawn wooden ornament for variety in their houses, and it is unfortunate that so much of that architectural detailing is being lost.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Silcox House is a central gable structure which is five bays wide, two bays deep, and two-and-one-half stories in height. It has a five-bay front porch and a rear ell. Stuccoed brick chimneys are enclosed in each gable and gable dormers project from the main house roof between the two end bays. The central gable is narrow--just over one bay wide--and has a small window with a pointed upper sash. The central entry door has a four-pane transom light and three-pane side light assembly with glass etched in an octagon and flower pattern. The door itself has round upper panels with bolection moldings on all four-panels and a diamond-shaped extra molding applied to the panel fields.

In recent years the structure was covered with white aluminum siding and original decorative detail removed. The only sawn wooden ornament that remains is on the handsome front porch. Its five bays are arched with delicate scroll work and the chamfered columns rest on 18" bases.

Windows have very narrow two over two sash; no trim is visible and shutters are missing. There are also two over two sash in the dormers; in the attic gables are four-pane casement windows.

The roof is covered with asphalt shingles. Its cornice and return overhang on all sides of the building and have an ogee crownmolding.

The rear ell is 27' long and 2½ stories tall with two gable dormers in each roof slope. Windows have six over six sash except the dormers which have two over two sash. There is a small shed porch and additions on the west side.

The interior stair is very handsome. Its newel and handrail are walnut, its bold turned balusters oak, and it is open to the attic. Interior doors have four panels with Grecian ogee and bevel moldings. On the first floor is one slate mantle and one simple wooden one; the second floor rooms have mantle shelves only.



A floor plan of the building is included in this report.

The front yard has remnants of an allay of trees which continues the allay of the Cloverleaf Farm (K-375) across the road. The buildings are on axis with one another and very similiar in design. Both of these houses were constructed by members of the Cochran family for their tenants, Abner (K-375) and Bedford Roe.

Behind the house are several wooden barns which date to about 1900. There is also a true 1½ story frame house with two rooms on each floor, a winder stair, and a gable roof. The floor joists are hewn but the structure has no architectural significance. It is used now as a garage.


INTERIOR WINDOW & DOOR TRIM
