The Cooper House at various times served as a social, governmental and commercial center of the community of Smithville, a small village which developed in the mid to late 19th century. The original portion of the house (2 rooms up and 2 down) were standing by at least the middle of the 19th century and included a southern addition which had a general store on the first floor and rooms for boarders above. There was also a blacksmith shop on the premises. In the years 1771-1780 the property was owned and the store operated by William V. Lucas, Esq. who was a Kent County Commissioner from the Third District in 1875, 1877, and 1879.

During the 1870's and 1880's the building was the meeting place of "The Improved Order of Redmen, Wicomico Tribe # 54, " a fraternal order who performed community service and cared for its members.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Smithville is a small group of houses located near the junction of Montibello Lake Road and Route 297 (Smithville Road.) One of the houses is this three-bay, two-story dwelling which appears to date from the mid to late 19th century and is similiar to other dwellings in the village. On the same property are two outbuildings from the middle of the 19th century, or before, that suggest that there was an earlier house on the property, or that parts of the present structure are earlier.

The house is two stories in height and has a rear addition with a catslide roof. The main house roof is a shallow gable with plain, unmolded eaves that overhang about 10".

There is a one-bay gable roofed entry porch and a hipped-roofed side porch, of recent date. Windows have 6/6 sash set in plain frames, or narrow beaded frames.

The house has been changed considerably in its lifetime. There formerly was an addition on its south side, and the present rear rooms were moved on to the site from a nearby farm. The Smithville Post Office was once housed in the side wing.

The interior of the house has simple window and door trim, four panel and board and batten doors, and plaster walls. There is a simple, late mantle shelf and an enclosed stair. A portion of wide pine flooring in one closet is the only visible evidence that an early building may be the basis of the present structure.

Behind the house is a stone ice-house with a pyramidal roof and a heavy board door. The floor of the building is about three feet below grade.

The other early building on the property is a gable-roofed shed covered by vertical boards. The roof rafters are exposed and the board door is hung on wrought iron strap hinges with arrowhead ends.


