

MEDDERS-KREBS HOUSE
Still Pond, Maryland
(1910)

Two stories plus attic in height, the Medders-Krebs House is frame and occupies a five bay square in plan. The building mass is roughly T-shaped with the leg of the T parallel to the street and one story porch running along the front and rear of the building. The roof is broad, sweeping, intersecting gables, visually connected to the walls by a deep fascia at the top of the wall. There is a generous two story bay window in the west wall.

This building is an example of the influence of Neo-classicism on vernacular design in the early 20th century. While spacious, the building is symmetrical and restrained, illustrating an aesthetic shift away from the assymetrical, picturesque buildings of the late 19th century. The house was built by William Medders, a storekeeper in Still Pond, in 1910. His daughter claims the design was copied from a house in Rollins Park, Baltimore.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Medders-Krebs House is located on the south side of the main street of Still Pond near its eastern edge.

Two stories plus attic in height, the house is frame and occupies a five bay square in plan. The building mass is roughly T-shaped with the leg of the T parallel to the street and one story porch running along the front and rear of the building. The roof is broad, sweeping, intersecting gables, visually connected to the walls by a deep fascia at the top of the wall. The house is covered with 4" weatherboarding which is terminated against narrow corner board. The porch has a shallow hipped roof supported by round columns which are doubled at the entry. There is a generous two story bay window in the west wall.

Windows are very wide and have one over one sash everywhere except in the bay wher the width of glass requires a central muntin. Trim and sills are plain. In the attic gables are "Palladian" windows, with a taller central, round headed upper sash.

The building is painted meduim grey with white trim. It rests on a brick foundation.

On the inside the house is laid out with a central hall plan. To the left is the dining room and kitchen, to the right double parlours, back to back. Major public rooms are connected by wide doorways, some with sliding doors, some hung with draperies. Doorways have spindle-work woodenportierre work on the first floor and glass transoms on the second. Window and door trim is reeded with a central curve and reeded corner blocks; most is left unpainted and is made of chestnut or oak. Doors have five panels. In the rear parlour is a fireplace with glazed terra catta surround and a latrobe stove. Flooring in all rooms is narrow oak boards.

The two-run, U-shaped stair ascends to a large, octagonal living hall on the second floor. It is also made of oak with delicate spindels.


