**Essex or Red Acres**  
**near Worton**  
**4th quarter 18th Century**

The single extant photograph of the house which once stood on Essex, portrays a three-bay, two-story brick dwelling with attached one-and-a-half-story wing. Built by Thomas Bowers in the late 18th century, little is known of its plan as it burned in 1916.

Thomas Bowers (1741-1784) was a member of the Quaker sect. Four years before his death he deeded 150 acres of Essex to his brother, John Bowers (1766-1820) (1). At the time of his death, John left a widow, Rosamund, and seven children. Of his real estate holdings, Essex was assigned to his daughter Mary Ann Bowers in 1840 (2).

In a deed dated 2 March 1880, Essex was transferred to George T. Williams (3) in whose family the farm remains today. According to Williams family tradition, George T. Williams (seated center in the photograph) had purchased the farm from his brother-in-law who had previously owned the farm but could no longer pay the taxes.

From the photograph, the house appears to have been similar to Worth's Folly and Duncan's Folly in form. Both of these houses had hall-parlor plans and similar chimney treatments, i.e. one chimney within the gable and the other partially protruding from the shared gable of the service wing.

One photo of the pre-1916 house which stood at Red Acres exists in the Williams family collection. The photograph shows a house which is similar to two other houses in the immediate vicinity. Worth's Folly and Duncan's Folly are similar in principal fenestration and general original form. All three had three bay facades, two story brick buildings, with one chimney inside the gable and the other on the exterior. Their service wings were 1½ storys tall, but the latter fenestration varied from house to house

The photo shows a three bay long two story brick house with it's principal east facade laid in Flemish Bond. There is neither belt course nor water table and the window lintels are composed of a row of vertical header brick. First story windows have 9/9 sash with 2-panel shutters. Second story windows have 6/6 sash and louvered blinds. A flat-roof porch (late 19th C.) protects the central entrance which is shorter than the flanking windows.

Off the south gable is a 1½ story, three bay long, service wing. The southernmost window is higher than the other and resembles Worth's Folly fenestration. The building was either heavily white washed or stuccoed and white washed, since the only brick visible is near ground level. The single dormer on its roof allowed light and air to the inner attic chamber.

The house burned in 1916 or 1917 and was replaced by the large frame house standing on the farm today. The old structure stood approximately 50 feet southwest of the present house and faced east.

Nothing is known of the interior plan, although the two aforementioned similar buildings still retain hall-parlor plans

Prepare both a summary paragraph of significance and a general statement of history and support.

The site of Essex is significant because it is another example of late 18th Century vernacular architecture built by a member of the Quaker Sect, in all likelihood, by Thomas Bowers (1741–1784).

150 acres of Essex was conveyed to John Bowers, (1766–1822) in a deed recorded in 1800. The deed stated that it had been mortgaged two years before and the land was formerly the property of Thomas Bowers, brother of John. Both Bowers were sons of Thomas and Ann Bowers, according to Quaker Records.

When John Bowers died in 1820, he left a widow, Rosamond, and seven children. When the estate was settled, the Essex part of John's holdings were assigned to Mary Ann Bowers in 1840. According to Williams family tradition, the farm came into possession of the single brother of Matilda Porter Williams, the wife of George Thomas Williams. The brother was unable to make the farm pay its way and it was finally sold to George T. Williams in 1880, the gentleman seated in the old photograph in front of the house. The farm has descended thru three generations of the Williams family to the present day.



Betterton Quad


