DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

When originally built, this house was constructed in the best syle. The main house is a five-bay structure that faces west. There is a central door with transom and sidelights, and a one-story, open porch with bracketed posts. Most windows are 6/6, and there are scalloped, large boards along the roof-line.

A low, one-and-a-half story wing extends from the SE corner of the main house. This may represent an earlier dwelling, but was most likely a kitchen. Some of the clapboard siding can be seen beneath the fake-brick, asbestos siding.
