DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

There are several, abandoned farmhouses scattered in this narrow, steep valley between Lewisdale and Price's Distillery Roads. Most are two-story, and some have one-story wings. It is likely that one was a part-log structure, and the others date from ca. 1900. The maps of 1865 show several homes in the area, and the Beall family appears to have been the principal occupant here for many generations.
