This is a farmhouse of local styling. It is built in an "L" shape, with the main part being a three-bay, gable-roofed section. A one-story porch runs around both parts of the house, and each of the windows have shutters on them. There are a number of notable outbuildings here, that include several log tobacco houses and a bank barn with basement windows on the gable ends.
