DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This was the location of King's Distillery and Saw Mill during the late-19th Century. According to the late Leslie C. King, there was also a cider mill there at one time. The whiskey made here was sent to Baltimore in barrels and bottled under the King label. The distillery itself burned down about 1907, but one of the warehouses stood until about 1971-when it was removed by Park and Planning(!) (See appraisal report from Adolph Rohland & Assoc., Inc.)
