<p>There are two buildings, a ruined frame outbuilding and a partially ruined log and frame house. The house was built in several sections. The east end is a story and a half log section with a two bay facade. It has a stove pipe on the east wall. The frame section to the west is one bay; on the west end is a stone fireplace with a brick stack. The fireplace opening on the west side of the base is now exposed since the west section of the house has partially collapsed. This west end was a two story building; probably the chimney was an external one on the east end.</p> <p>The interior is lathed and plastered with chair rails and baseboards. Staircases are small, corner, boxed stairs.</p>
