DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The house was built in three sections, two of log construction and a frame ell. The older log end is one room with a second room and central staircase added. The original house is a full two stories; the addition has log walls 1-1/2 stories tall with a framed wall bringing it to a full two story height. This may have been done when the frame ell was added. At one time, there was an external end chimney on the oldest section; it stood where the present staircase rises.

The house has a four bay facade, the two center bays being doorways. A central gable was added at same time.
