DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

These are the ruins of an old, water-powered mill. (Martinet's Map of 1865 shows both a Saw Mill and a Bone Mill here.) The wheel pit is visible, and holds water where the road has cut off the flow of the out-race. There is a stone foundation visible here, and the race is very much intact and runs parallel with Hyattstown Mill Road east, to the area of the mill-pond (perhaps 100 yards or more.)
