DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The house is a two story structure built in two sections. The northerly one is three bays with the two northern bays being doors. The southerly one, also three bays, has a central doorway. The north end has a small chimney. The eaves and slope of the gable end have bargeboards. The house is now covered with aluminum siding.

A corncrib resting on stone piers, stands behind the house. There is also a large bank barn with a stone foundation. Both are sheathed in vertical boards. The bank barn has blind arches that give the appearance of windows.
