The older farmhouse here may not be the original one, but it appears to be similar to the Reid house along Slidell Road, near Boyds. It is an L-shaped, two-story, frame building, with a three-bay (east) main facade and a central door. Stove-type chimneys are located in each of the end walls. The building is covered with asbestos shingles.

Nearby are several farm buildings, including a large frame bank barn, with a shingle (wood) roof.
