DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a rubble-stone masonry foundation, consisting of two, parallel walls. The stone is Seneca Sandstone, and it appears that part of it was laid "dry" (without mortar.) There are quoin blocks at the corners. The ruins (referred to as a "warehouse", "granary", etc.) apparently once were covered by a frame section of walls and roof above. However, because of the dimensions and openings in the walls, it may be that wagons were able to drive into the space and unload grain onto canal boats that used to tie up in the now-dry basin here.

The walls have been capped with concrete in recent years to prevent further deterioration.
