DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a nice, small barn, made of Seneca Sandstone. It has the appearance of an "English" barn (i.e. small rectangle-not built into the bank, as in "German" barns.) It is one-story-with-loft, and the walls are laid in coursed rubble. There is a small, central door in the south facade that is topped by a segmental, stone lintel. There is a tin roof, with board-and-batten, gable-end sheathing.
