STATEMENT OF SIGNIFICANCE

There was no house built on this property, but its history goes far back into the history of the Big Woods community.

In the 19th century, it was part of the Hempstone estate and was sold to Benjamin White in 1845, as recorded in deed STS 1/42. In 1890 it was sold to the white landowner, Andrew Clinton Brown, who lived in the Barnesville vicinity. He did not live in this community, according to Florence Hallman from Big Woods. In 1909, the Brown family sold this tract of 2.76 acres to John C. Owens, as recorded in deed 210/401. Owens then sold the land to Thomas Dawson in 1913, according to deed 238/374. And finally in 1919, Louisa E. Owens purchased the tract from Thomas Dawson, Mary A. Dawson and Ida C. Owens, the wife of John C. Owens. According to Florence Hallman, Louisa Owens was the mother of Jess and Courtney Diggins. Jess Diggins was raised in the house adjacent to this tract according to oral tradition. The title is still in the name of his mother.

As part of this survey, two of the photographs of the Diggins family collection were copied. One was of Rev. D.L. Washington, minister of the Mt. Zion Church, and the other was of Nettie Mary Owens, born in 1894 and died at age 17, sister of Jessie and Milton Courtney Diggins.

This log house of the Diggins family was representative of the type occupied by many Black families near the turn of the 19th century and into the 20th. In fact for some people, such as Jessie Diggins who lived here, the log house was the only type they lived in during their entire lives.
