9. Description: This two-story frame ell-shaped farmhouse with cross gable pediment faces east. Built on fieldstone foundations, the house is now sheathed with aluminum siding. The central block is five bays by two bays (2/2 lights) with a central entrance flanked by sidelights and surmounted by a transom. Windows are framed with green louvered shutters. There are two interior end chimneys on the central block. The gable roof has slate shingles; its eaves have boxed cornices and a central pediment with centered arched window. To the west is a two story ell that has 3/6 double-hung sash second floor and 2/2 on the first floor and an exterior stone chimney. A one story addition with a raised seam metal shed roof extends as a garage on the west and north ends of the ell. To the northeast is a complex of farm buildings, including a bankbarn, silo, wire corncrib and several storage sheds.

10. Significance: This frame farmhouse, situated in the rolling foothills of Sugarloaf Mountain, is representative of a house type found throughout Montgomery County and the Mid-Atlantic region. Adjacent to lands held by the Perraré family for 150 years, the grouping of the handsome white house and its red bankbarn adds a special element of historical and architectural continuity to the scenic Sugarloaf landscape.

Around 1860 William Thompson purchased 124 acres of "Mount Vernon" for about \$1,000 and built this house. He and wife Julia moved to Frederick County (Park Mills) in 1878, and sold the farm to Octavius O. Baker who kept the farm until 1895. John and Mary Cooley bought the farm and in 1902 conveyed it to her nephew Frederick Cooley. He and his wife Annie lived there until 1915. It had several intermediate owners before being purchased by the present owner in 1945.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story frame el-shaped farmhouse with cross gable pediment, situated in the rolling foothills of Sugarloaf Mountain, is representative of a house type found throughout Montgomery County and the mid-Atlantic region.

Built on fieldstone foundations, the house is now sheathed with aluminum siding. The central block faces east and is five bays by two bays (2/2 lights) with a central entrance flanked by sidelights and surmounted by a transom. Windows are framed with green louvered shutters. There are two interior end chimneys on the central block. The gable roof has slate shingles; its eaves have boxed cornices and a central pediment with centered arched window. A one story screened porch has been added to the main (east) facade. The first story of this facade still displays the original German siding.

To the west is a two story el that has 3/6 double hung sash on the second floor and 2/2 on the first floor and an exterior stone chimney. A one story addition with a raised seam metal shed roof extends as a garage on the west and north ends of the el.

The farmhouse is approached from the north (Comus Road) on a long (several hundred yard) entrance road. It passes through pastureland with grazing cattle. To the northeast of the house is a complex of farm buildings including a bankbarn, silo, wire corncrib and several storage sheds.

STATEMENT OF SIGNIFICANCE

The exact date of construction of the William Thompson House, a typical up-county farmhouse of the mid-19th century, is uncertain. Around 1860 William Thompson purchased the land, 127 3/4 acres of "Mount Vernon", paying Benjamin Hawkins a preliminary \$25 toward the total purchase price of \$1,000. However, Hawkins died in 1861 without having executed a deed of conveyance. Thompson paid the rest of the money to Samuel Thrift, administrator of Hawkins' estate, and a formal deed was finally executed in 1863. It seems likely the house was built before this date, however, possibly as early as 1860 or 1861.

By 1878 Thompson and wife Julia had removed to Park Mills in Frederick County, and the following year they sold the Comus farm to Octavius O. Baker, also of Frederick County, for \$2,150. The property now contained 130 3/4 acres.² Baker occupied the farm until 1895, when he sold the property to John F. and Mary Cooley for \$4,550.³ Mary Cooley died on May 4, 1900, and two years later her widower conveyed the farmstead to Fred Cooley, one of the various heirs-at-law of Mary Cooley, in consideration of \$3,000.⁴ Fred Cooley and his wife Annie occupied the house and land until 1915, when they sold the property for \$9,200 to George E. Gregg.⁵ The farmstead then passed through a number of hands until being purchased by the present owner in 1945.
