The house is a two story, frame structure with a five bay main (north) facade. The doorway is centrally positioned. The cornice is bracketed and the window heads have architraves. The doorway is colonial revival, with transom and sidelights with flanking fluted pilasters. The foundation is stone. The external chimney on the east end is rebuilt.

West of the house is a frame barn and a log springhouse.
