The Stephen Lewis House, also known as the Ed Lewis House at 23730 Frederick Road in Clarksburg, Montgomery County, is not considered eligible for listing on the National Register of Historic Places.

The Stephen Lewis House is a two-story, three-bay frame dwelling, built in the mid-to late 19th century and which incorporates part of an older, possibly 18th-century log house. The property was purchased by Stephen Lewis in stages, in the period between 1797 and 1831. The present house on the site is a representative example of rural domestic architecture and lacks the architectural distinctiveness and integrity necessary to qualify it for listing on the National Register of Historic Places.

Environmental Setting Recommendation:

- on the east by the long north/south row of pine trees which begins at Frederick Road and ends just south of the house, and then continuing southward from there along a line for approximately 1000' until it intersects the southern boundary described below;
- on the south by the fence (or line extension thereof) which runs in an east/west direction approximately 600' south of the house and 75' south of the largest barn; and
- on the west by a line running in a north/south direction, from Frederick Road to the fence described above which defines the southern edge of the setting; the line would be approximately 600' feet west of the house at its closest point.

The setting would include the outbuildings, a pond west of the house, and the driveway from Frederick Road to the house.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ed Lewis farmhouse is a three-bay, 2½ story log-and-frame I-house with a side-gable roof covered in corrugated metal; it faces north onto Frederick Road. The cornice is boxed and returned and there are exterior chimneys at the east and west ends of the main block. The house has six-over-six double-hung windows, shuttered on the main facade. There are two small four-light casement windows in the east gable end and one small four-light casement window in the west gable end. The entire house is sheathed in German siding.

Built in stages on a fieldstone foundation, the original eighteenth century log structure (incorporated into what is now the east section of the house) was a one room, two-story building to which a one-story log room was added on the west. The house continued to grow with a second-story frame addition above the west log room.⁽¹⁾

The one-story entrance portico has a concrete slab base; two chamfered wooden posts support a pedimented gable roof covered with corrugated metal. The entrance door has round-headed panels.

The north (front) door opens into a narrow hall. Directly ahead (to the south) a closed-string, single-run stairway with winders ascends from north to south. Down two steps to the west is the dining room; west of the dining room is the kitchen. To the east is the living room. South of the living room is a bedroom and to the west of the bedroom is a small bathroom. The family room, in the southwest corner, is accessible from the kitchen. There is random width flooring in the oldest sections of the house. Walls and ceilings are plaster over lath. The doorways have simple frames and the doors are wooden paneled.⁽²⁾

There are several early-mid twentieth century additions to the structure, which (although substantial in size) do not overshadow the original block. On the east elevation there is a one-story, gable-roof wing (originally used as a garage) which was erected in the 1920s; it has a corrugated metal roof and German siding. Now converted for other uses, entrance is through a four-paneled door in the north facade.

At the rear of this wing is a one-story, shed-roof enclosed porch with an entrance on the south elevation; the roof is corrugated metal. To the west of the porch is a two-story, two-bay gable-roof wing which extends to the rear from the southeast corner of the main block. The wing has a returned cornice, a corrugated roof, a small six-pane window in the gable end, and is covered with German siding.

On the west elevation, at the northwest corner of the main block, is a one-story, one-bay, gable-roof kitchen which was added in the 1920s; a large shed-roof family room was attached to the rear of the kitchen in the 1960s. There is an entrance to the family room on both the east and west elevations of the kitchen wing and an exterior chimney on its south elevation. The kitchen wing has a concrete-block foundation.

There are several outbuildings on the property which were initially thought to be on a neighboring parcel because of their distance from the house and particular setting. The consultant was later refused permission by the property owner for a site visit to photograph and record a description of the outbuildings.

STATEMENT OF SIGNIFICANCE

The Ed Lewis Farm is historically significant because it is representative of an earlier period in the County's history when agriculture was the predominant industry. In addition, it was associated for many years with the Lewis family, one of the early families in the area, and, specifically, with Mahlon T. Lewis, one of the founders of the town of Boyds. Architecturally, the house is significant because it is a late nineteenth century rural vernacular structure which has (in spite of more recent additions) retained its architectural integrity. In addition, an earlier eighteenth century log house is enclosed within the existing nineteenth century structure, unusual in that such log houses were often demolished to make way for the larger frame houses which replaced them.

The Lewis farmhouse is located on part of several tracts know as "Three Brothers", "Woodport", "Pleasant Plains", and "Moneysworth" which Edward Lewis purchased between 1838 and 1856 for a total of approximately 290 acres.⁽¹⁾ Lewis, who may have built the frame addition which incorporates the log structure, is listed as the owner of 291 acres, part of "Three Brothers", on the 1876 tax list, with improvements valued at \$500; he is also shown as a property owner on the 1878 Hopkins Atlas.⁽²⁾ By 1878, the value of improvements had risen to \$700, and, in 1897, after his son Mahlon T. Lewis acquired the property, improvements are listed as \$900, indicating that Mahlon Lewis may have enlarged the structure further.⁽³⁾

Edward Lewis (identified in the 1870 census as a 60 year old farmer with real and personal property valued at \$4400) died intestate in 1884 leaving his widow, Mary A. Lewis, and four children. By order of the Circuit Court of Montgomery County, Lewis' land was sold at auction on February 2, 1889 by Trustee James B. Henderson; the successful bidder was his son, Mahlon T. Lewis.⁽⁴⁾

An advertisement for the property in the Montgomery County Sentinel in February of 1889 describes Lot #1, for 162¼ acres, as being "improved by a two-story frame dwelling house, two tobacco houses, a barn and other necessary outbuildings and has also upon it a good apple orchard."⁽⁴⁾ It appears that the existing structure was located on Lot #1.

Mahlon T. Lewis was a Clarksburg businessman who owned a considerable amount of property in the area. In 1878 he moved to Boyds and opened a store next to the newly-established B&O Railroad depot. Lewis, his business partner James E. Williams and Col. James Boyd (who worked for the B&O) were instrumental in the growth of the town of Boyds, which developed around the railroad.⁽⁶⁾

Mahlon Lewis died about 1920, and, in 1921, J. Frank Lewis, his son, sold parcel #1, "the first parcel described in the deed conveyed from James B. Henderson, Trustee, to Mahlon T. Lewis" to Georgiana L. Norris, along with parcel #3, for a total of 260 acres;⁽⁷⁾ Mrs. Norris was Mahlon T. Lewis' daughter. She owned the property until 1927, when it was sold out of the Lewis family to Robert Summerson. The property then passed through several owners before it was conveyed to Peyton G. Nevitt in September, 1936.⁽⁸⁾ Mr. Nevitt's daughter, Catherine Sherwood, is the current owner of the property, which has been in the Nevitt family for over half a century.

Although Mr. Nevitt was not himself a farmer, the property was farmed for many years by Mr. Sherwood's uncle, Mr. Burkett, who also maintained a small dairy operation. The vegetables which he raised were trucked to a nearby cannery in Gaithersburg, while the wheat was shipped to Bowman's Mill in Germantown, both now gone. Mr. Burkett still lives in the house and continues to farm and to keep cows.⁽⁹⁾

9. Description: This five bay, two-and-a-half story log and frame house was built in stages and is now sheathed by white novelty siding. Built in stages: the east section was a one room, two story structure to which a one story west room was added. A frame second story was added above the west room and east and west one room, one story additions were later built. Recently a family room was added to the southwest. House has six-over-six double-hung windows. Gable roof is covered by corrugated metal.

10. Significance: This 18th century log house, now completely enclosed within a mid-19th century frame house, was owned by an early Clarksburg family, Lewis, and later by two of the founders of the community of Boyds.

Stephen Lewis had lived in Clarksburg for some time before his first real estate purchase in 1797 of part of the tract of Moneysworth, a quarter acre lot with house. Lewis died intestate in 1853, and Cambden R. Nicholls bought the property at a sheriff's sale. Improvements on the Lewis property at the time of sale included the log dwelling houses, blacksmith shop, and stables.

In 1854 Nicholls deeded the property to his daughter and son-in-law Sarah and Thomas Nichols. James E. Williams of Boyds bought the farm from Nichols in 1878. Williams sold the property to Mahlon T. Lewis, another Boyds founder, in 1905.

The property changed owners several times before it was purchased by the present owner in 1936.

In 1954 Route I-270 was built, bisecting the Moneysworth tract (the two Lewis farms), breaking the road which connected them. The western part was sold to M-NCPPC, and is now used as a sludge trenching site, but this eastern section is still farmed by the owner.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This five bay, two-and-a-half story log and frame house faces north on Frederick Road.

Built in stages on fieldstone foundations, the east section was a one room two story log structure to which a one story west room was added. The house continued to grow with a second story frame addition above the west log room, a two story south ell off the west room and one story east and west wings on the north addition. The present owners added a family room at the southwest corner. The entire house is sheathed by white novelty siding. This siding undulates across the north elevation.

The north (front) porch has a poured concrete slab base in front of the front door. Two chamfered wooden posts support a shed roof with corrugated metal covering. The north (front) door is wooden and has round-headed panels.

The house has six-over-six double-hung windows flanked by green board and batten wooden shutters. There are two small four-light casement windows in the east gable end and one small four-light casement window in the west gable end.

The gable roofs are covered by corrugated metal. The cornice is boxed and returned. At the east and west ends of the two story north section there are exterior end chimneys. The new family room has an exterior chimney on the south elevation.

The north (front) door opens into a narrow hall. Directly ahead (to the south) the closed string, single run stairway with winders ascends from north to south. Down two steps to the west is the dining room; west of the dining room is the kitchen. To the east is the living room. South of the living room is a bedroom and to the west of the bedroom is a small bathroom. The family room, in the southwest corner, is assessable from the kitchen. There is random width flooring in the oldest sections of the house. Walls and ceilings are plaster over lath. The doorways have simple frames and the doors are wooden paneled.

STATEMENT OF SIGNIFICANCE

This is an 18th century log house completely enclosed within a mid-19th century frame house.

Stephen Lewis bought parts of lots 10, 11, and 12 in Clarksburg between 1797 and 1831, amounting to nearly 10 acres, mostly from the tract, Moneysworth.¹ As one of the deeds mentions buildings and improvements, the log house enclosed in the present large frame home may have been on the property when it was purchased by Lewis, and dates to the 18th century.

Lewis had lived in Clarksburg for some time before his first real estate purchase at this site. He bought household goods and livestock in 1793,² and a quarter acre lot with house in 1797.³ In 1839 at the age of 65 he married Mary Holland, age 43.⁴ Lewis died intestate in 1853, the same year Camden R. Nicholls bought the property at a sheriff's sale. Improvements of the Lewis property at the time of sale included the log dwelling houses, blacksmith shop, stables, etc.⁵ The current owner has found coins dating from 1797 in her front garden.

When he bought this property in 1853, Nicholls also purchased adjacent parcels to increase the size of the farm. The following year he deeded the property to his daughter and son-in-law, Sarah and Thomas Nichols.⁶

Edward Lewis (not Stephen's son) lived on this property and farmed a considerable amount of acreage. His son, John, lived in the house on the western part of Moneysworth.⁷ Edward Lewis may have built the addition which incorporates the log structure.

James E. Williams of Boyds bought the farm from Nichols in 1878.⁸ Williams sold the property to Mahlon T. Lewis in 1905.⁹ Mahlon T. was Edward Lewis' son.¹⁰

The property changed owners several times before it was purchased by the present owner in 1936.

In 1954 Route I-270 was built, bisecting the Moneysworth tract (the two Lewis farms), breaking the road which connected them. The western part was sold to M-NCPPC, and is now used as a sludge trenching site, but this eastern section is still farmed by the owner.


