DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>The house was built in several sections. The two log parts were built independently and are off-set. The north end is two irregular bays with a stone chimney on the north end. The smaller, south end, is also two bays with an exterior stone chimney on the south end. The bays are V-notched except for the southwest corner of the north building, where the joints are dovetailed. Both sections are a story and a half, with boxed staircases. Rafters are birdmouthed over the top log and the loft rooms are ceiled below the collars. Behind the north end and adjoining the north wall of the south end is a frame lean-to connecting passage. The attic of this covers the gable end of the south log section; the old, wide clapboards of this gable can be seen here. The interior walls are plastered, with lath applied horizontally over vertical furring strips; under the lath and plaster, the insides of the logs and chinking are painted and were probably once exposed. The fireplaces were large, both with large wooden lintels in the south end the opening was made smaller by adding a lower segmentally-arched opening.</p>
