9. Description: This T-shaped, two bay by four bay, one story building faces east onto Ten Mile Creek Road. It has six-over-six double-hung windows and a gable roof covered with asphalt shingles. The house is sheathed in white aluminum siding on three sides; the rear (west) facade has German siding exposed.
- The front (east) section, forming the cross bar of the T, has a cement block foundation. The back (west) part's foundation was not seen.
- The east section is two bay by one bay. The roof ridge runs north-south. The west section is three bay by one bay, and the roof ridge is east-west.

10. Significance: Ten Mile Creek Schoolhouse (for white children) was one of the first public schools in the County, operating from 1868 to 1936. It was the site of the organization of Boyds Presbyterian Church in 1870, as well, and religious services were held there for six years until the Presbyterian Church was built.
- The school had been in operation two years when the Board of School Commissioners bought the half acre of property from Samuel P. and Amanda Nichools in 1870. William R. Winchell was the teacher there for 30 years, resigning in 1904.
- In the 1920's it was made into a "model school"; windows on one side were covered, and the students' desks placed at an angle to receive the correct amount of light over their left shoulders.
- The school was closed in 1936, during a period when County schools were consolidating. The building was sold to Haywood James Martin and his wife Lucille Elizabeth in 1942. They converted the school into a dwelling, adding the wing. The Martins sold it in 1969, and their son bought it back in 1974.


DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This T-shaped, two bay by four bay, one story building faces east onto Ten Mile Creek Road. It has six-over-six double-hung windows and a gable roof covered with asphalt shingles. The house is sheathed in white aluminum siding on three sides; the rear (west) facade has German siding exposed.

The front (east) section, forming the cross bar of the T, has a cement block foundation. The back (west) part's foundation was not seen.

The east section is two bay by one bay. The roof ridge runs north-south. The west section is three bay by one bay, and the roof ridge is east-west.

Adjacent to the house on the west is the cement block foundation for a third wing, forming an I with the original building sandwiched between two parallel wings.

SPECIFIC DATES 1868-1936 BUILDER/ARCHITECT Montgomery County Board of School Commissioners

STATEMENT OF SIGNIFICANCE

A school for white children operated here from 1868 to 1936. It was one of the first public schools in the county.¹ The Board of School Commissioners bought the half acre of property from Samuel P. and Amanda Nicholls in 1870, also receiving a right of way to a nearby spring.²

The Boyds Presbyterian Church was organized in this building in 1870, and held religious services here until their edifice was ready for occupancy six years later.³

In August, 1880, the trustees of the school met to discuss adding another room due to crowded conditions. Local citizens felt that two teachers were needed instead of the one presently employed.⁴ William R. inchell was the teacher for thirty years, resigning in 1904.⁵

According to a former Ten Mile schoolteacher, it was made into a "Model School" in the early 1920s, indicating interest in progressive, experimental methods of education in the county. The windows on one side were covered, she said, and the students' desks placed at an angle to receive the correct amount of light over their left shoulders. The school had no water; one of the boys was sent to fill the school's bucket from a spring. There were two outhouses behind the school, one for girls and one for boys.⁶

During a period of consolidation, the school was closed June 9, 1936.⁷ Offers to purchase the school from the Board were at first rejected, but Haywood James Martin and his wife, Lucile Elizabeth Martin, bought the school and half acre in 1942.⁸ They converted the school into a dwelling, adding the wing.

Lucile Martin sold the property to Charles E. Yokley in 1969.⁹ Yokley sold it to John T. Bell in 1971,¹⁰ and Bell sold it to the son of Lucile and H. James Martin three years later.
