DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is no longer standing. According to Dorothy Lockett Curtis, it was owned by her uncle Daniel Thomas Jackson in the 1920s. It was a one and a half story frame dwelling with one room down and one up. The front door was located in the center of the facade, and a window was placed next to it. Along one gable end was a brick stove flue. Opposite the front door was a back door. A boxed stairway ascended along one gable wall inside the house. The design of the house was quite plain, inside and out.

STATEMENT OF SIGNIFICANCE

According to Dorothy Curfis, this house was rented by her uncle Daniel Thomas Jackson. She did not remember any of the names of the families who rented the house except the Wallace family. The house was smaller than the other homes of Black landowners in the community since it had only one room down and one up. Its earlier history, as a rented house such as date of construction or the status of its occupants, is unknown.

The presence of a stove flue in this house indicates that it was built in the last quarter of the nineteenth century.
