Description:

The Gertson Property is a 3-bay vernacular house with two additions on the west side. Constructed circa 1890, the original part of the house is 1½-stories, has an asphalt shingle side-gable roof, is of wood frame construction with vinyl siding, and has a fieldstone foundation. There is a porch on the east side constructed of wood post and beam, which is partially shielded in plywood. The porch has a brick foundation and a sloped plywood roof with asphalt shingles. An interior chimney with aluminum flashing is located at the south side of the house.

The northwest addition is 2-stories with a sloped, asphalt shingle shed roof; it is of wood frame construction with vinyl siding, and has a concrete block foundation. There is a 1-story lean-to at the southwest corner of the house, connected to the original part and the northwest addition. The lean-to has an asphalt shingle roof, is of wood frame construction with vinyl siding, and has a concrete block foundation.

There are four outbuildings associated with the property. The first outbuilding is a structure with a standing seam metal gable roof; it is of wood frame construction with vertical board siding, and has a fieldstone foundation. The second outbuilding is a structure with a standing seam metal gambrel roof, and exterior walls of concrete block approximately 2.44 meters (8 ft.) high, and wood frame with vertical board siding above that level. The third outbuilding is a small structure with a corrugated metal gable roof, and is of concrete block construction. The third outbuilding is connected to the second outbuilding by a wood frame hyphen with a corrugated metal, flat roof. The fourth outbuilding is a small structure with a standing seam metal roof, and is of wood frame construction with vertical board and batten siding.


The property is located on rolling farmland, near the end of Kruhm Road, with a small grove of trees near the house, and a wooded area west of the outbuildings. The land immediately adjacent to the property is pasture land.




Resource Sketch Map
