Description:

The Wright Property is a 1½-story, 3-bay Bungalow-style house on the west of Bell Road in Burtonsville vicinity, Montgomery County. Constructed circa 1920, the structure has a side-gable roof covered with asphalt shingles, with exposed rafters and knee braces. There are large dormers on the north and south facades, also with knee braces and exposed rafters. An exterior brick chimney is located on the east facade. The structure is of wood frame construction with aluminum siding, has a concrete foundation, and double-hung wood windows. There is a 1-story full-width integral porch on the south elevation. The porch has square wood columns on concrete piers and no railing. An attached garage of concrete construction extends east from the east facade and is banked into a slope. The flat roof of the garage has brick piers and a wood railing.

There are two outbuildings associated with this property. The first outbuilding is a wood frame shed, with a metal front-gable roof, constructed circa 1930. The structure is located west of the house.

Constructed circa 1950, the second outbuilding is a wood frame chicken coop with a shed roof, covered with corrugated plastic. The structure is located west of the house, and of the shed.

In addition, there is a well located at the northwest corner of the house.


The property is located on the west side of Bell Road, with open space to the east and west, residential property to the north and south. The property setting is rural in feeling.
