Section 7.1

This barn is located on Annapolis Rock Road near the Patuxent River right across from what used to be the Mullinix Mill site. This barn, of frame construction, rests on a foundation that is composed of loose fieldstone and has many corners that are missing segments of the foundation. The entire structure is covered with vertical wood siding and has a rusted tin roof. Overall the barn is in poor condition, but could possibly be upgraded to provide better shelter. This structure may be part of the Mullinix Mill site that was located directly across the street, and if this is the case it could date from the late nineteenth century.


