Description:

The Duvall/Kruhm House, constructed circa 1860, was previously surveyed by the Maryland-National Capital Park and Planning Commission (M-NCPPC) in 1973, 1976, and 1979, and was designated as a historic site by the M-NCPPC in 1981, in the Master Plan for Historic Preservation. The main house has had two alterations since the previous survey.

The slate roof on the property has been replaced with asphalt shingles. In addition, the screened porch in the rear ell has been enclosed to accomodate a two car garage.

National Register Evaluation:

The Duvall/Kruhm House, constructed circa 1860, was previously surveyed by the Maryland-National Capital Park and Planning Commission (M-NCPPC) and was designated as a historic site by the M-NCPPC in 1981, in the Master Plan for Historic Preservation. The property is eligible for the National Register under Criterion C, as an intact example of a vernacular farm complex, including the main house, a bank barn, and a stone smokehouse. Despite some alterations to the main house, the structure retains integrity of form and material, and its setting remains intact, despite intense development of the surrounding community. The period of significance of the property extends from circa 1860 to 1947. The property is not eligible under Criterion A, as research conducted indicates no association with any historic events or trends significant in the development of national, state or local history. Historic research indicates that the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. In addition, it has no known potential to yield important information, and therefore, does not meet Criterion D.

Verbal Boundary Description and Justification:

The National Register boundaries of the Duvall/Kruhm House follow the current property lines of 15900 Kruhm Road (Tax Maps KS 342 and KS 343, Lot/Block #P75 and P110). This 17.47 hectare (43.19 acres) parcel is bounded on the north, south and west by adjacent tax parcels, and on the east by Kruhm Road. All structures within the proposed boundary contribute to the significance of the property, including the main house, a barn and a stone smokehouse. According to deed research, the property was originally part of a 101.5 hectare (251-acre) parcel which was purchased by Lewis Duvall in 1851. Smaller tracts were sold to various family members during the 20th century, resulting in the current parcel. The property is now bounded to the north by high-tension wires and a public utility right-of-way, and to the south, east and west by residential development.

9. Description: This three bay by five bay, two and a half story frame house faces south. The original weatherboarding is now covered by white asbestos shingles. The south (front) porch has a shed roof supported by four chamfered wooden posts and decorated by brackets. There is a screened porch on the east elevation of north ell. There are six-over-six double-hung windows throughout. The gable roof is covered by slate shingles.

10. Significance: The Duvall-Kruhm homestead is an excellent example of a 19th century family farm owned, worked, and well maintained by the descendants of the original builder to the present time. The house, and farm buildings were built by Lewis H. Duvall, who bought a 251 acre tract in 1851, and moved there with his wife, Jane Spencer in 1853, first living in a log cabin. He built the farmhouse by 1865, the bank barn by 1868, and the smokehouse by 1869, and the blacksmithship, granary with shed and woodshed before 1900. He added the rear addition to the house about 1898. His son Charles built a two room addition on the east side, later damaged by fire and not rebuilt. Lewis Duvall's youngest daughter, Mary married Frederick Kruhm in 1903, and since then three generations of Kruhms have lived on the farmstead.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three bay by five bay, two and a half story frame house faces south.

Built on fieldstone foundations, the house originally had weather-boarded exterior walls, but these have been covered in recent years by white asbestos shingles. The south (front) porch has a shed roof with raised seam metal covering supported by four chamfered wooden posts. There are decorative porch brackets. The south (front) wooden paneled door has four small transom lights set into it. There is a screened porch on the east elevation, off the north ell, with a shed roof. Two glass and wooden paneled doors open onto the screened porch.

There are six over six double hung windows throughout the house. There is a six light casement window in the east gable.

The gable roof is covered with slate shingles, and is the only slate roof found in Burtonsville. The cornice line is boxed. There are east and west interior end chimneys, designed for stove use only. The plan is symmetrical about a central stair with one room on either side. There is no stair hall; access to the rear addition is through the room to the right of the stair.

The south door opens into a small entry way. Directly ahead a closed string single run stairway ascends from south to north. To the east is the dining room and to the west is the living room. The kitchen is north of the dining room.

Visible floor joists are uncut logs. There are new narrow hardwood floors in the first level room. The walls and ceilings are plaster over lath. There are glass paneled and wooden paneled doors throughout the house.

In 1924 Fred Kruhm replaced the original wooden porch floor and posts with a cement floor and new posts. When Norman and Beatrice Kruhm purchased the house in 1939, they divided the house into two homes for the two families living there. The house had two kitchens and 3 flights of stairs. After a 1955 fire, four rooms were removed, the two rooms at the north end of the rear wing, and a room with the bay window on the ground floor and the room above. While this remodeling was being done, an outside entrance to the cellar was found under the extension built by Charles Duvall in 1903. A new chimney was built in 1955 to replace the original one which caught fire, causing extensive damage to the east side of the house. During this reconstruction, brick was found between exterior studs of the house.

A slate-roofed stone smokehouse and a large post and beam bank barn date from 1868. A cold storage room exists in the barns lowest floor. Norman Kruhm said he removed the old log cabin in the 40s; depressions can still be seen about 300 ft. north of the existing residence which outline the cabin's foundations.

STATEMENT OF SIGNIFICANCE

The Kruhm-Duvall homestead, with the original house and farm buildings, is an excellent example of a 19th century family farm. It was built by a young farmer who built his home, made additions to the house as his family increased in size, built his farm buildings and added to them as the need arose, planted orchards, and increased his holdings in livestock and personal property. This farm has been owned, worked and well maintained by the descendants of the original builder to the present time.

The Kruhm-Duvall House is situated on a tract of land which was purchased by Lewis (Louis) H. Duvall from Issac B. Iglehart on Feb. 13, 1851. The tract, composed of 251 acres, was a part of Bear Bacon and was purchased for \$600.¹ Duvall was born in Prince George's County in 1827. He married Mary Jane Spencer in 1853, and they had 8 children. From the original tract, Duvall sold 15 acres for \$610.³

Duvall moved to his land between 1853 and 1857, having either built a log cabin or moved into one that already existed.⁴ He built his new house with a slate roof, bay window and front porch prior to 1865.⁵ Lewis Duvall is said to have gotten the slate for the roof of the house and smokehouse from a quarry near Sugarloaf Mountain in Frederick County, Union troops having searched his loaded wagon on the return trip to see if he was concealing weapons.⁶ The farm buildings, particularly the bank barn, on the foundation of which "Duvall" and "1868" are inscribed, and the smokehouse were probably built prior to 1869, at which time the assessment records indicate an improvement to the property valued at \$1,500.⁷ According to Norman Kruhm, resident from 1907, and owner 1939-1975, Lewis Duvall built the blacksmith shop, granary with shed and woodshed, prior to 1900. Lewis introduced Kieffer pears to the area, and planted them alongside his apple and plum trees. He also added the rear wing to the house about 1898. Prior to 1903, Charles Dickerson Duvall, (son of Louis, Uncle of Norman) who was farming the place at the time, built a two-room addition to the north of the two-story bay window on the east side of the house. The bay window and the attached two rooms were damaged in a 1955 fire and not rebuilt.

Three years after the marriage of Lewis and Mary Jane Duvall's youngest daughter Mary Lillian to Frederick Kruhm in 1903, the Kruhms bought the home place, 125 acres, from Lewis Duvall for \$4,000.⁸ In 1939, the Kruhms' second son, Norman, and his wife purchased the property from his parents.⁹ In turn, their son Larry E. Kruhm in 1975 purchased from his parents two parcels, 25.636 acres and 21.152 acres, containing the house and farm buildings.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The house is a 2-1/2 story frame rectangular farm-house with a 2 story rear wing. A one story porch with bracketed posts extends across the main (south) facade. At the east and west ends are small internal chimneys; at the attic level, narrow 4/4 windows flank the chimney stacks. According to the owner, the main part of the house is 110 years old, and the kitchen wing is 50 years old.

Several interesting outbuildings remain on the property: a stone smokehouse with a slate roof and flat brick arch over the doorway and a bank barn with a cat-slide roof on the banked facade. The barn rests on a stone foundation and is sheathed in vertical boarding; on the east side is a lean-to addition.

Acreage Justification:




