DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE	
<p>The house is a three-story, frame structure with a five-bay, main (east) facade. There is a central gable with an arched, louvered window. There are internal chimneys at either end. The cornice is returned into the gable end. On the interior, there is a central hall and flanking rooms on each floor; the windows have panelled reveals hiding folding shutters. The doors and mouldings are mid-19th century.</p> <p>To the south is a one story stone wing. It has a three-bay facade, the two north bays being doors. The chimney is positioned between the first and second bays from the south. There is a cornice of three courses of brick, the upper and lower headers and the middle set at an angle. The south gable end has a door and a narrow gable window. The main facade has one dormer (added later). The plan is three rooms; the south and middle rooms have very large fireplaces (now closed off), one of which has a Federal style surround. The partition walls are plastered brick. The exterior was plastered.</p> <p>South of the house is a log smokehouse. North, is a framed corn crib and a frame bankbarn with a sotte foundation. The barn has vertical board siding and square-headed louvered window openings.</p>

The W. T. Jones House is a late nineteenth century rural vernacular dwelling, not unlike those built throughout Montgomery County during the late nineteenth and early twentieth centuries, in its basic form (rectangular main block and a gable roof with a center gable). The house was probably built by William T. Jones about 1890.¹ This house may well be a replacement dwelling for an earlier, probably stone, house which was built on the original foundation. This would explain the unusual proportions of the house which is a full three stories high and only one bay deep. Perhaps the earlier dwelling could no longer accommodate the family.

Pre-dating the house is an attaching, single story stone wing, plastered over on the exterior. This wing originally served as the kitchen, dating back to Solomon Simpson's 1783 Plantation.² This stone kitchen is of particular note, including architectural features such as a cornice of three courses of brick, the middle course set at an angle, and a sandstone drain through which waste water passed from the kitchen. Simpson was a farmer of considerable means who came here from Frederick in the later 1700's. He lived here with his wife, Dorcus and ran a large farm, worked by two dozen or so slaves.³ Simpson died in 1803 and in 1804 the plantation of 421 3/8 acres was purchased by Solomon Davis, a nephew.

Later, in 1837, the property was purchased by Francis Pyles.⁴ Francis farmed here with the aid of approximately nine slaves,⁵ until his death in August of 1848. The property was then sold by a court appointed trustee so that the proceeds could be divided between Francis' six living children. It was then described as approximately 420 acres of "Simpson's Dwelling Place," "Johnny & Molly's Conclusion," etc. improved by, "a good stone dwelling plastered outside and good and sufficient outbuildings."⁶ This description probably refers to an earlier dwelling which would have resembled the existing kitchen building, also constructed of stone plastered on the outside.

In January of 1851, the property was purchased by William and William T. Jones, father and son, from Washington, D.C.⁷ In 1867, it was conveyed to William T. Jones exclusively. Boyd's, History of Montgomery County, Maryland lists William T. Jones as a farmer and a Commissioner of the School Board. He lived here with his family in what was probably an early stone dwelling which he replaced with the present frame structure sometime around 1890. William died in 1903 leaving a widow and four children. The property, described as 424 1/4 acres with a frame dwelling, was offered for sale in 1905.⁸ It was purchased by three of William's Children; Dr. Eugene Jones, Mary M. Jones and Sarah C. Hamill. They retained possession of the farm until 1919 when it was sold to Thomas J. and Nettie R. Oland of Frederick County, Md.⁹ The Olands sold it in 1941 after which time the property passed through a succession of owners. It was purchased in 1963 by the Cafritz Foundation.¹⁰ It has been tenanted out to the Morgan family for many years.

Also included on the property is a large frame bank barn and a chinked, log meathouse, both in good condition, and the ruins of a log house.
