DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a very unusual, L-shaped house that was probably built ca. 1900. The main block appears to be the leg of the "L" that extends SW. This has a hip roof, with a narrow, stove-type chimney emerging from the apex of the roof. There is a bay window on the west side and the tall windows have 2/2 sash. The other leg of the "L" extends to the NE, and has an odd, shed-type addition on the north end. There are no openings in the addition, save for a narrow, hinged door, that appears to have been cut into the side sometime after the original construction. A two-story porch, with turned posts and a second-story railing, is set in the ell formed by the "legs" of the house. The siding on the house is a very narrow, German tongue-and-groove siding.

There is a frame barn nearby.



APPENDIX A

SITES NOT RECOMMENDED FOR REGULATION UNDER THE
HISTORIC PRESERVATION ORDINANCE CHAPTER 24A OF THE
MONTGOMERY COUNTY CODE

The following sites have been reviewed by the Montgomery County Historic Preservation Commission and were found not to merit designation on the Master Plan for Historic Preservation. If not included in the Master Plan, these resources may be removed from the Locational Atlas and Index of Historic Sites in Montgomery County. If removed from the Locational Atlas, the site will no longer be governed by the Moratorium on Alteration and Demolition, Section 24A-10 of the County's Historic Preservation Ordinance. The sites will, however, remain on the Maryland Historical Trust's Inventory.

The following sites were found by the Preservation Commission to be too greatly altered from the period of their architectural or historical significance or not to meet Ordinance criteria for designation.
