The house is a two story, sandstone building with a two story stone wing. The main block is laid up in coursed, dressed stone with quoined corners; the wing is laid up in uncoursed stone. The facade is five bays, with a central doorway. The windows are 4/4 double hung sash with false segmentally arched heads formed by moulded framing. The roof is hipped, with a "widow's walk" having a balustrade of sawn, openwork, design. The front porch has paired columns on either side of the steps. The cornice is brackets. The balustrade is composed of turned posts. At either end are two interior brick chimneys. The wing, set back from the facade, repeats the motif of the main block.
10. Significance The land on which Rocklands sits has been associated with the Allnutt family for over 200 years. James Allnutt originally came to this section of the Seneca Creek basin from Prince George's County around 1750. By his death in 1786, James held 746 acres, which he divided amongst his sons. James' son Lawrence by his 1825 will passed on his share (supplemented with additional acreage) to his sons Benoni and Lawrence. The 2 brothers jointly possessed the land until their deaths in 1859; as Benoni never married, the land was divided amongst Lawrence's children, and Lawrence's son Benoni took the 171 1/8 acres between Dry and Great Seneca Creeks. To a house on this property Benoni brought his new bride in 1860.
Benoni Allnutt proved to be a successful farmer, and soon became a prominent and distinguished figure in the community. He had built for himself in 1870 of native stone a grand home reflective of his success.
Benoni Allnutt died in 1899, and the farm remained in the family until 1949. The present owners purchased the property in 1955.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The house is a two story, sandstone building with a two story stone wing. The main block is laid up in coursed, dressed stone with quoined corners; the wing is laid up in uncoursed stone. The facade is five bays, with a central doorway. The windows are four over four double hung sash with false segmentally arched heads formed by moulded framing. The sills and lintels are both cut stone blocks.

A broad wooden frieze encircles the house below the boxed cornice. The frieze carries the paired brackets; between sets of brackets, a panelling motif decorates the frieze. The roof is hipped, with a "widow's walk" having a balustrade of sawn, openwork, design.

The front porch has paired columns on either side of the steps. The cornice is bracketed. The balustrade is composed of turned posts.

At either end are two interior brick chimneys.

The wing, set back from the facade, repeats the motif of the main block.

Surviving outbuildings include a framed bankbarn on a cut sandstone foundation; a two story, log quarters with board and batten siding and a large, external stone chimney; a sandstone dairy; and a log meathouse.

STATEMENT OF SIGNIFICANCE

This portion of Montgomery County in which the "Rocklands" is situated has been associated with the Allnutt family for over two hundred years. James Allnutt originally came to this section of the Seneca Creek basin from Prince Georges County around the year 1750. By the time of his death in 1786, he held 746 acres of "Thomas' Discovery", which, by his will, was divided amongst his sons. Some 171 acres, with "...the dwelling houses where I do now dwell" was devised to his wife Jane Allnutt. To his son Lawrence Allnutt, James Allnutt bequeathed 171 acres of "Thomas' Discovery".

(1) Lawrence supplemented this with a purchase of 88 additional acres of "Thomas' Discovery" from Roger Johnson, on December 5, 1818. (2)

Lawrence Allnutt died in 1825, and by his will, probated on June 10 of that year, devised these two parcels of "Thomas' Discovery" (the original 71 acres being the dwelling plantation of Lawrence Allnutt) to his sons Benoni and Lawrence. (3) This acreage was added onto by the conveyance of 171 1/8 acres of "Thomas' Discovery Fortified" from Ann Vinson to Lawrence Allnutt, on November 2, 1849. (4) The two brothers agreed to a joint possession of the lands, with Lawrence Allnutt granting to Benoni "...that tract conveyed by Ann Vinson to Lawrence Allnutt and also the free use and enjoyment and possession during the natural life of Benoni of the dwelling house, out houses, stables, barns, etc., on the farm or plantation whereon the said Lawrence and Benoni now reside in common with the said Lawrence and his family...and that the said Benoni may make the same his home or domicil during his natural life, without cost, charge, or molestation". (5)

Both Lawrence and Benoni Allnutt died in August of 1859; Lawrence on the 20th, and Benoni on the 4th. Benoni Allnutt never married. Consequently, the various heirs of Lawrence Allnutt petitioned the courts for an equitable division of their father's land. Benoni Allnutt (born in 1835), exercising his right as an elder son, elected to take that 171 1/8 acres of "Thomas' Discovery Fortified", bounded on the west by the road to Seneca Mill, on the south by Dry Seneca Creek, and on the east by the Great Seneca Creek. The court-commissioned surveyor's plat, dated June 4, 1860, depicts a dwelling situated upon this part of "Thomas' Discovery Fortified". Whereas Lawrence Allnutt's house, Benoni's boyhood home was located on that section of "Thomas' Discovery" directly north of and adjacent to Benoni's elected parcel, and was taken up by his brother, Benjamin W. Allnutt, it is not known exactly who constructed or originally occupied this dwelling. In any case, it was to this house that Benoni Allnutt brought his new bride in 1860. (6)

This residence, the subject building, was completed in 1870, and was constructed of native stone. A noted state historian, in an 1882 publication, stated that "Mr. Allnutt's home is one of the finest in the county...(It) is not only a handsome architectural specimen, but embodies all the comforts and conveniences that improved skill and refined taste could suggest" (7)

Benoni Allnutt died on May 30, 1899, but the farm remained in the Allnutt family until 1949. The present owners purchased the property in 1955.


