STATEMENT OF SIGNIFICANCE

This tract was part of the 11.5 acres that Nancy Turner purchased from Jane E. Jamison in 1908 (deed, 198/388). In 1912 one and one eighth acre was conveyed to Nathan Hebron, husband of Mallie Turner, the daughter of Nancy Turner. In 1930 it was conveyed by the heirs of Nathan and Mallie Hebron to Nannie Isabel Talley (deed, 502/39).
