DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Though this log house has been destroyed, it is remembered by Mary Turner, the daughter-in-law of Nancy Turner. According to her, the house was rather similar to the log home of David and Susie Turner nearby.

In brief, this one and a half story log house had two rooms down and two up. A front porch sheltered the facade. The logs were exposed and were not painted or whitewashed.

One room downstairs was used as the kitchen and the other as a parlor and dining room. The rooms upstairs were bedrooms. The walls were plastered inside. The kitchen had a wood burning stove and the other room a smaller tin stove, called a "king heater." Instead of brick chimneys, tin stove pipes were used.

Since the log home of David and Susie Turner is still standing, refer to the descriptions and photographs of that house for more details. According to Mary Turner, the yards and outbuildings of the Nancy Turner place were similar to those described on the David and Susie Turner homestead.

STATEMENT OF SIGNIFICANCE

This site was the homeplace of Nancy Turner and her family in the early 1900s. According to the deed, 198/388, she purchased a tract of 11.5 acres (of which this site is a part) from Jane E. Jamison in 1908 for \$114.50. The tract was a portion of the much larger tract known as "Buck Lodge." The deed also states that she paid for the land in full.

It is possible that the log house was built at the time of purchase by Nancy Turner. But it is also likely that she was already living there, perhaps working for the Jamisons and purchased the land on which she was living. It does appear that 1908 is late for the construction of a log house, instead of a frame one. Mary Turner and other members of the "younger generation" (now in their seventies and sixties) do not recall the history of this house except to say that it is known to be an "old house".

In 1914 a small portion (1.69 acres) of the larger tract of 11.5 acres was conveyed to Douglas A. Turner by the heirs of Nancy Turner, as recorded in deed 250/105. Douglas Turner continued to live in the log house of his mother and in 1963 deeded the land to the current owners (deed 3158/623).


