The John H. Gassaway house is a large circa. 1872 Victorian style farmhouse, built in parts. The house is more elaborate than most of the farmhouses in the area and includes some interesting architectural detailing. In addition, it is in an original condition. Unfortunately its now vacant state is a threat to its future.

The house was built about 1872 by John H. Gassaway.¹ John purchased the land on which his house was constructed, 116 3/4 acres of the "Vienna" and "Resurvey on Buck's Bottom" tracts, from George and Ann Robertson in August of 1871 for \$1,150.² Based on the styling of the house, John, a farmer, was quite prosperous. He served as the sixth president of the Montgomery County Agricultural Society.³ Groups such as this one were formed in the county in an attempt on the part of the farmers to improve farming methods, and were very important to agriculture in their regions. The additions were made to the house during the late nineteenth century, probably between 1894 and 1897.⁴

The house remained in the Gassaway family until December of 1911 when Alexander A. and Bettie F. Gassaway sold it to Jacob Hammann.⁵ The farm remained in the Hammann family for many years also. In May of 1948 it was passed on to Ralph Charles Hammann, and stayed in his possession until a few years ago when it was purchased by the Department of Natural Resources, the present owner.⁶

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The John Hanson Gassaway farm complex is located on the south side of Riffle Ford Road, east of Germantown Road (Maryland Route 118). The main house is a two-story, frame structure built in several sections. It consists of two, two-story, end-gabled wings connected by a lower two-story section, the basic plan being an "I"-shaped one.

The main facade (north facade of the north wing) is four bays wide with an open porch extending across the first story. This wooden bracketed porch is supported by latticed iron uprights. A transomed doorway is located in the second bay from the western corner. Three 4/4 double-hung sashed windows with simple molded, paneled aprons define the remaining bays. Elaborate timber surrounds with cornice window heads and corbelled end sills frame these window openings. Four 4/4 double-hung sashed windows mark the corresponding second-story bays. Lintel and sill treatment of these windows is identical to that of the first story windows. A simple lunette is located in the peaked central gable. Internal brick chimneys are found at both gable ends.

The east facade of this wing is two bays wide. A transomed door with a bracketed gable roofed hood and a 4/4 double-hung sashed window define the first story. Two 4/4 windows mark the corresponding second story openings. All windows share the same lintel and sill treatment with those of the north facade. A lunette is located at the attic level. Looped bargeboard decorates this gable end.

The two-bay, west (rear) facade of this wing is distinguished by a 1/2 double-hung sashed window in the southernmost bay at the first story level, and two 1/2 double-hung sashed windows at the second story level. A small lunette pierces the gable end at the attic level. All windows have simple timber surrounds. A bulkhead flanked by basement windows is located at ground level.

The east facade of the south wing is one bay wide with a screened porch extending across the first story. A central door on the first story, a 4/4 double-hung sashed window with a plain timber surround on the second story, and a smaller 4/4 double-hung sashed window at the attic level define this facade.

The west facade of this wing is marked by a 9/6 double-hung sashed window, a 2/2 double-hung sashed window and a lunette at the first, second and attic levels, respectively. Window treatment is similar to that of the east facade of this wing.

Little distinguishes the fenestration of the three-bay, two-story south facade of the southern wing.

The east (main) facade of the lower two story central section is two bays wide with a shed roofed, double porch spanning the entire width of the facade. Transomed doors are located in the northernmost bay at both levels. A trio of double-hung sashed windows and a single double-hung sashed window distinguish the first and second story levels, respectively.

A gable-roofed dormer with 2/2 double-hung sashed window is found on both this and the west facade of this central section.

The interior of the Gassaway house is in fair condition with most of the original Nineteenth Century doors, woodwork, trim and mantels still intact.

Assorted outbuildings surround the farmhouse. The most interesting structure is a one-story, whitewashed, vertical planked log smokehouse. Adjacent to this building are chicken coops and a wind pump. Twentieth Century barns and a corn crib are found in the nearby field.

STATEMENT OF SIGNIFICANCE

Gassaway complex, a prosperous Nineteenth Century farm now stands idle, dwarfed by PEPCO utility lines and surrounded by urban sprawl in lower Montgomery County. John Hanson Gassaway, a successful gentleman farmer and prominent businessman of Montgomery County, was a typical exponent of the changes which occurred in farming techniques in the third quarter of the Nineteenth Century.

During the late Eighteenth and early Nineteenth Century in Montgomery County, because of poor farming methods used in the cultivation of tobacco and wheat, the soil was severely depleted of its natural fertilizers.¹ As a response to these problems, agricultural societies were organized (Sandy Spring Farmers' Society, 1799; Columbian Agricultural Society, 1809; Sandy Spring Farmers' Club, 1841; Montgomery County Agricultural Society, 1846) by the more prosperous county farmers in an effort to bring planters together to discuss better farming techniques. These groups were thus able to experiment with expensive machinery and chemical fertilizers. The latter of which, introduced in 1843, greatly contributed to the successful reclamation of the soil.²

John Hanson Gassaway actively supported these agricultural concerns. He served as sixth president of the Montgomery County Agricultural Society in the late 1870s, early 1880s.³ Also, he operated a successful fertilizer and grain store in Germantown, Maryland in the latter half of the Nineteenth Century.⁴

Architecturally, the Gassaway farm house represents a curious evolution of what is commonly referred to as an "I"-house, distinguished by three bay width and one bay depth.

Pursuant to your telephone call this morning, I enclose a copy of our Maryland Historic Sites Inventory form for the above-referenced property in Seneca State Park. I hope this is useful to you in your efforts to appraise the building as part of the upcoming DNR effort to deaccession this property.

The survey of this property was done in February, 1979 as part of a larger MHT effort to evaluate all historic properties within the boundaries of state parks throughout Maryland. Although Ms. Bridget M. Deale, our field surveyor at that time, stated that the property was not eligible for listing on the National Register of Historic Places, I feel the property may indeed be eligible, certainly on the grounds of the importance of Gassaway, and because of the structure's architectural detail. We would be pleased to work with DNR or a new owner to complete such a nomination. I enclose the pertinent section of the recommendations section of Seneca State Park section of the report for your review.


As for the terms of the easement on the property which would be given to the Trust, I would say the building should be transferred with, at minimum, an exterior easement, and very possibly an interior easement as well. I would suggest that you contact Mr. William Pencek, Chief of our Technical Preservation Services branch, at 224-2212 (MARCOM), about scheduling an inspection of the property. Because almost five years have passed since the survey was undertaken, Mr. Pencek or a staff member should examine the structure and then let you know whether an easement on the interior is necessary.


