The Watkins farmhouse is a rural vernacular dwelling built in parts, the earliest of which probably dates from the 1850's. It was later substantially added to in 1885. The house now, however, has more of a twentieth century look due to such alterations as the new brick chimney on the west side and the application of stucco to the original frame exterior.

The earlier part of the house was built by Thomas Hunter, a farmer and miller who came to Montgomery County from Baltimore County in 1851.¹ He died in 1857 leaving his property to his wife, Susanna G.K. Hunter and their children. Susanna sold the house on 105 acres to George S. Watkins in October of 1873 for \$2,965.00.²

Following George's death a few years later the farm became the property of his son, Rudolph Watkins. Rudolph had the substantial additions made in 1885 by Cole and Orme, Contractors of Barnesville, essentially building a new house.³ With his wife, Mary, and their family, Rudolph ran a farm here which he referred to as "Dixie."⁴ In May of 1896, the house was sold to William T. and Nani F. Owens who in turn sold it to the fields family in May of 1909.⁵ In August of 1940, the Fields sold the house to the present owner, Lawson King.⁶
