The Hunting Hill Store and Post Office at 10515 Darnestown Road in Montgomery County is not considered eligible for listing on the National Register of Historic Places.

Originally built in the late 19th century as a store and post office separate from the residence of the storekeeper, Hunting Hill Store and P.O. has since been significantly enlarged and converted into a single-family dwelling. The first postmaster of the Hunting Hill Store and Dwelling was Ignatius Beall Ward, who was appointed in 1872. Ward was postmaster until 1893 when Elmer E. Magruder took over the job. Ward resumed his position in 1897 and remained there until the post office closed in 1905. Ward also ran a wheelwright and blacksmith shop at that location and dabbled in real estate, buying and selling hundreds of acres of land in the area. The store and post office stood directly on Darnestown Road in front of his own residence. Ignatius Ward died in 1909; in 1929 his granddaughter converted the former store into a residence and still lived there in 1979.

The Hunting Hill Store and Post Office has been significantly altered and its original character as a store and post office has been compromised. The property no longer retains sufficient architectural integrity to qualify for listing on the National Register of Historic Places under Criterion C.

9. Description: This four bay by three bay, two-and-a-half story house faces south. Built on fieldstone foundations, there is an east one-and-a-half story, three bay by one bay section with beige clapboards and a west, two-and-a-half story, three bay by one bay section with gray clapboards. The south (west) door is glass and wooden paneled. There is a poured concrete slab in front of this door. The south (east) door is a vertical wooden paneled gate which leads into an interior entry way. There is a porch on the east elevation with a shed roof supported by two chamfered wooden posts. There are two glass and wooden paneled doors on the east elevation. There is a screened porch on the north elevation. There are six-over-six double-hung windows throughout the house. The intersecting, parallel and perpendicular gable roofs have asbestos shingles and boxed cornice lines. There are east and west exterior chimneys.

10. Significance: This attractive residence on what is currently a beef cattle farm was originally a combined country store and post office. Its first postmaster was Ignatius Beall Ward, who was appointed in 1872. Ward was postmaster until 1893 when Elmer E. Magruder took over the job. Ward resumed his position in 1897 until the post office was closed in 1905. Ward also ran a wheelwright and blacksmith's shop at that location. In addition to his work at the store and post office, Ward bought and sold hundreds of acres of land, owning nearly 500 acres at the time of his death in 1909. The store was then run by his son Porter Garrett Ward. Later it was rented out and the Ward family shifted their business interest to Rockville where they owned the Ward Brothers timber and hardware business. The old store was converted into a residence in 1929 and is still lived in by I.B. Ward's granddaughter, Elizabeth Banks, who farms the surrounding land. The Ward family cemetery is across the road.

STATEMENT OF SIGNIFICANCE

This attractive residence on what is currently a beef cattle farm was originally a combined country store and post office. Its first postmaster was Ignatius Beall Ward, who was appointed June 13, 1872.<sup>1</sup> The two-and-a-half acres of land on which the store/post office was to be built was bought by Ward for \$310 the previous year.<sup>2</sup> The property is described on the Hopkins Atlas of 1878 as "B. Ward store and post office"<sup>3</sup> (Ward was commonly called "Beall") and is listed in Boyd's 1879 History of Montgomery County... as "Store, Wheelwright and Blacksmith Shop and Post Office" in Hunting Hill.<sup>4</sup>

I. B. Ward was born February 23, 1841, the fourth of six children of William Ward and Verlinda Beall Ward. After Verlinda died in childbirth, Ward married again and had eight more children.<sup>5</sup> I. B. Ward and his wife Elizabeth Garrett had eight children: Frank S., Beulah, Willie J., Mercy Beall, Porter Garrett, Catherine Georgia, Henry Clay and Frances Lucinda, all born in the store. Around 1891 they moved to a much larger house on the hill above the store, but when it burned down the family again moved temporarily to what must have been very cramped quarters at the store.<sup>6</sup>

I. B. Ward continued as postmaster until June 20, 1893, when Elmer E. Magruder took over the post, but resumed his job on July 2, 1897 and held it until the post office was closed November 15, 1905.<sup>7</sup> In those days it was common for a rural post office to be located in a country store.

In addition to running the store and post office, I. B. Ward bought and sold hundreds of acres of land, both in Hunting Hill and across Muddy Branch Road, and at the time of his death owned nearly 500 acres.<sup>8</sup>

When Ward died on October 2, 1909, he left all his farms and "the store he now operates" to his wife, Elizabeth Garrett Ward.<sup>9</sup> The store was then run by their son, Porter Garrett Ward, for some years. Mrs. Esther Crown, whose father worked for the Ward family at that time, remembers her grandfather carrying the mail from the post office on horseback and bringing goods in a one-horse wagon from Rockville for the store.<sup>10</sup>

Later the store was rented out. Meanwhile, Porter, his older brother, Frank, and their brother-in-law, Roland Banks (husband of Frances and father of Elizabeth B. Banks) were running the Ward Brothers timber and hardware business in Rockville. In 1929, the year after I. B. Ward's wife, Elizabeth died, they converted the store into the house it is now, putting the original front porch in back and covering the old weatherboard with new siding of pressed wood. The building was considerably enlarged, the left front section of the present house being the location of the original store. (The log part of the old store is still visible in the basement.) That same year Roland and Frances Banks and their children moved into the

converted house. The current resident, Elizabeth Banks, who was 15 at the time, has lived there ever since. A retired school teacher, she has farmed the property alone since 1958 and has 90 head of beef cattle.<sup>11</sup>

After Elizabeth Garrett Ward's death in 1929, I.B. Ward's holdings were distributed to his living children, some of whom sold out to others in later years. Through inheritance from her mother<sup>17</sup> and aunts Catherine and Beulah, and purchases of her own, Elizabeth Banks has acquired three-quarters of the farm of 134 acres, the remainder being the property of her brother and sister. The farm includes the large house on the hill, the former store/post office where Miss Banks lives, five tenant houses, two large barns and several cow sheds. The Ward cemetery is across the road; Victorine, Johanna and Iradell, all daughters of I.B. Ward, are buried there. Ward himself is buried in Rockville.
