The Mills House, located east of I-270 and southwest of Gaithersburg in Montgomery County, is not considered eligible for listing on the National Register of Historic Places.

The Mills House is a large, frame American four-square-type dwelling which was once part of the Mills family farm. The house is set upon a low foundation and is covered with a hipped roof with four hipped dormers on center of each slope of the roof. The house is two bays-by-two bays, defined by pairs of windows in each bay. A one-story, partial wrap-around porch identifies the south elevation as the main facade of the house.

The Mills house survives as a good, local example of an American four-square-type house, but lacks the architectural distinctiveness and integrity to qualify it for listing on the National Register of Historic Places under Criterion C. In particular, the widow's walk, which once capped the hipped roof, is missing. The property is not known to have associations with persons or events significant to our past and thus does not qualify for listing under Criteria A or B. The property was removed from the Locational Atlas for Montgomery County by the M-NCPPC in 1983.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a square, Colonial Revival, frame house with a hip roof. There are large dormers on each of the roof's four sides. The roof has a flat peak, which indicates a balustrade or "Widow's Walk" may have capped the structure at one time. There is an open, one-story porch that wraps around the main (south) facade and SE corner. There is a central door on this facade, with a transom light. There are two sets of double windows on the second story.
