This is an interesting piece of masonry-the only one of its kind in the county. Built to carry traffic underneath the RR tracks (obviously before the popular use of the car) it is a narrow, arched tunnel built of rough-dressed ashlar blocks. There is a one-course parapet that rests across the top, and the arch itself has a keystone lintel. The sides of the structure are reinforced with diagonal buttresses.

Nearby, on Game Preserve Road, is a two-story frame building, allegedly used as a schoolhouse years ago.

The B&O Railroad Underpass is an early twentieth century ashlar block narrow arched tunnel. The underpass was part of the Metropolitan Branch of the B&O, a great local advance in transportation and a stimulus to growth and trade in Montgomery County.

The underpass was probably built about 1906 when the B&O Railroad double-tracked this stretch of rail between Gaithersburg and Germantown.¹ Prior to this time all (except two) railroad crossings on the B&O were constructed of wooden trestlework. It was not until the early twentieth century that these wooden and iron bridges were replaced with stone structures such as the railroad underpass.² In addition, the underpass is very similar in design and composition (and can be compared to) the Waring Viaduct and the Little Monocacy Viaduct both built between 1906 and 1907.³ The underpass of course was constructed on a much smaller scale and was built to serve a slightly different purpose. It is supposedly the only structure of its kind in the county.

An interesting aspect of the underpass is that it was apparently built in two parts. Approximately 2/3 appears somewhat newer than the remaining 1/3, being of the same design but constructed of much more finished looking blocks. Also, a seam where the two sections are joined can be seen from the interior of the underpass.



ACTION TAKEN

I am pleased to transmit to you a copy of the Final Draft Amendment to the Master Plan for Historic Preservation: Gaithersburg Area Resources. This Plan recommends that only one of the remaining Gaithersburg area resources (the Belward Farm/Ward House, Site #20/21) be placed on the Master Plan for Historic Preservation.

This Amendment recommends against the designation of the following resources on the Master Plan:

- . Railroad Underpass, Site #20/30
- . Mineral Spring Houses, Site #20/10 1 & 2
- . Sylvester Thompson's House & Store, Site #20/11
- . Fields/King Farm, Site #20/12
- . Watkins Farmhouse, Site #20/13
- . Briggs Farm #2, Site #20/26
