STATEMENT OF SIGNIFICANCE

This farm was supposedly owned by the Thompsons or Ranneys during the 19th Century. Without a doubt, however, the best-known owner was Herman Rabbitt, who lived here during this century. Mr. Rabbitt was a highly-successful farmer and cattle dealer. His death in 1972, at the age of 81, attracted much attention-especially after it was discovered that he had buried part of his multi-million dollar fortune in milk cans on the farm here. Legends regarding Mr. Rabbitt's habits abound.
