There was a fine, old frame house on this site that burned in the 1930's. Today, a small frame cottage remains, and there is a large stone chimney nearby. The farm buildings appear to be the oldest structures still standing. These are clustered about a wooded grove, and include a frame bank barn, corn crib, etc.

STATEMENT OF SIGNIFICANCE

These were the lands of the Brookes family during the 19th Century. T.B. Brookes owned a considerable amount of property, including a number of lots in Washington and Gaithersburg. These lands were divided by a Mont. Co. Equity Court (case #4851) in 1927 among the heirs, the Starkey and Hendry families. Most of the farm is in the 18th Century patent known as "Grandby".

According to James Starkey, one George O. Kephart bought the farm in the 1920's, but failed to pay for it, so the family foreclosed. During this period, someone was running a still in the old house, and it blew up-burning down the house in the process. The Equity Case (#4851) resulted in an ad in the MONT. CO. SENTINEL (July, 1927) that described "former lands of Thomas B. Brookes" for sale, since George O. Kephart has defaulted, "where formerly stood the mansion house"; also, two tenant houses, large barracks, stable, double corn crib, granary, wagon shed, etc.



9. Description: This five bay by four bay, two-and-a-half story log and frame house sits on a hill facing east. Built in sections, the original log house probably faced south. To it was added a north ell and, in 1865 a two-and-a-half story, five bay by one bay east addition. The house now has white aluminum siding. The east porch has shed roof supported by two square wooden posts. The south porch has a shed roof supported by four brick posts which extend the full two stories. The house has six-over-six double-hung windows. Intersecting gable roofs are covered by black asbestos shingles. The southeast room in the east section served for a time as the community school.

10. Significance: Flint Hill is associated with the Bowie family, distinguished in Montgomery County's early history. Built before 1826, and enlarged in the mid-century, the house was used as a school in 1918 and 1919.

John Bowie, Sr. came to Maryland from Scotland about 1705. His great grandson, Washington I, born in 1776, became one of Georgetown's most wealthy and public spirited citizens, founding a successful shipping and export business. He retired to Montgomery County in 1820, purchasing 2,000 acres south of Olney. Part of this tract included the Flint Hill Farm with its appurtenances. When Washington I died in 1826, Flint Hill was given to his son Thomas Johns Bowie, a Harvard graduate and "a scholarly, polished gentleman". His wife Catherine sold Flint Hill in 1874 to George W. Hyatt. Sold to Margaret A. Fraley in 1891, she later conveyed it and its 215 acres to her sons, Harry H., Ernest L. and Charles (in 1912). Fraley School was operated by Lulu and Harry Fraley in 1918-1919. In 1942 the 161 acre property was sold to Harry H. (grandson of Margaret A. Fraley) and Eleanor P. Fraley, the present owners.
