DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Apparently, this place was used as a tenant farm for the adjacent Cashell farm during the late-19th Century. The house is a plain, L-shaped structure with a three-bay (south) facade. There is a central, stove-type chimney. Present siding is asbestos shingle.

The old frame barn recently was demolished. It did not have a bank-type foundation, but rested on the level ground. It had hewn framing, and an old shingle roof. It was a local landmark that sat on a high hill above Rte. 115.


