Name of Property: Abland V Limited Partnership House

Location: 4007 Muncaster Mill Road, Norbeck vicinity, MD 20853

The Abland V. Limited Partnership House was surveyed in 1996 and was recommended as ineligible for listing in the National Register of Historic Places. The property is visible on the Panchromatic Digital Orthophoto Quarter Quads (DOQs) from 1998 (Maryland Environmental Resources and Land Information Network [MERLIN]). High Resolution Imagery from 2007-2008 confirm the house is no longer extant (ibid.). Demolition Permit #341039 was issued for the residence on April 21, 2005 (dataMontgomery).
