The E. R. Griffith farm house is significant as an example of vernacular architecture typical of that constructed in Montgomery County from the mid-nineteenth through the early twentieth centuries. The Griffith family were among the early settlers to the Laytonsville area and had extensive land holdings. The house is believed to have been built by Elisha R. Griffith, a farmer and businessman, about 1855.¹ The house sat on 8 acres and 12 perches of land tracts referred to as "Addition to Brooke Grove" and "Retirement." Elisha had purchased the land in December of 1854 for \$500 from Lucretia Griffith (daughter of Henry Griffith I).²

In October of 1883, Elisha died leaving the "plantation," including all buildings on "Retirement" and "Brooke Grove" to his wife, Elizabeth, and his daughter Mary. To his son Charles (judge of the Orphans Court) he left the "plantation" on which Charles then resided.³ In November of 1880, Elizabeth and Mary sold their inheritance to Charles for \$3000. This included 102 acres and 10 perches with 8 acres attached on which Elisha's house sat.⁴

In March of 1889 Charles and his wife, Hester, sold the house to Sarah A. Clagett.⁵ Sarah added a small piece of land purchased by Charles Griffith but never recorded, bringing the acreage up to 10 acres and 8 perches.⁶ Sarah sold the house to Edward Barber in May of 1900.⁷ Then in June of 1941 Edward sold the house to the present owners, Edwin and Susan Fry.⁸ The house then sat on 11.77 acres, Barber having added to the property in 1924.⁹

Attachment Sheet

A date of 1855 has been given to this house based on the tax assessment records and the purchase date for the property. This house, however, may be earlier. Its basic configuration, a small rectangular main block, one and a half story with a lean to like front and rear (the roof in front sloping down to form the roof of the porch), conforms to that of the dwellings of earlier settlers built during the first decades of the nineteenth century. In this case, the house would have been constructed as the home of Henry Gaither who owned the property in the early nineteenth century and whose heir sold it to Elisha R. Griffith in December of 1854.

SITES NOT RECOMMENDED FOR REGULATION UNDER THE
HISTORIC PRESERVATION ORDINANCE CHAPTER 24A OF THE
MONTGOMERY COUNTY CODE

The following sites have been reviewed by the Montgomery County Historic Preservation Commission and were found not to merit designation of the Master Plan for Historic Preservation. If not included in the Master Plan, these resources may be removed from the Locational Atlas and Index of Historic Sites in Montgomery County. If removed from the Locational Atlas, the sites will no longer be governed by the Moratorium on Alteration and Demolition, Section 24A-10 of the County's Historic Preservation Ordinance. The sites will, however, remain on the Maryland Historical Trust's Inventory.


The following sites were found by the Preservation Commission to be too greatly altered from the period of their architectural or historical significance or not to meet Ordinance criteria for designation.


I am pleased to transmit to you this Preliminary Draft
