9. Description: This frame store served the Unity community from the 1880s until it was transformed into a private home a short time ago. This two story, L-plan house has white asbestos siding. There are two porches on the north (front) elevation. Both have shed roofs supported by narrow wooden posts. The east porch has a balustraded railing. There are two-over-two double-hung windows. Many have been replaced by modern one-over-one double-hung windows. The house has an intersecting gable roof covered by raised seam metal.

10. Significance: This building for most of its lifetime has been used as a general store, and as such has been a focal point of the rural village of Unity.

In 1843 Nimrod Davis had purchased two acres in Unity and set up his blacksmith business. Davis's daughter Lucretia married Lloyd C. Colliflower of Frederick County and together with James Harvey they opened a general store before 1878. Lucretia and Lloyd inherited the property in 1882 and Lloyd continued to operate the store after Harvey sold out in 1890, but the following decade was not a prosperous one for him. The store was sold by mortgage default in 1896. Joshua Higgins operated the store from 1899 until the 1920s. It was then operated by Charles Zeigler, and most recently by Fletcher and Litsinger Brown. It was converted to a dwelling in the late 1940s.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame building served the Unity community as a store until it was transformed into a private home a short time ago.

Built on stone foundations, this two story, L-plan structure has been covered by asbestos siding. There are two porches on the north (front) elevation. Both have shed roofs supported by narrow wooden posts. The east porch has a railing with square balusters, while the west porch is entirely open. The house has a gable roof covered by raised seam metal covering.

One original two-over-two double-hung window remains in the east wing on the north elevation. The remainder of the windows have been replaced by modern one-over-one double-hung windows. On the east wing the door and window have been interchanged as part of the modernization process the house is undergoing. The owner stated that the double glass and wood doors leading into the west wing would be replaced by a modern door.

The floor plan is two large rooms: the east room is now the kitchen. The west room, formerly the store, is being modernized and will serve as the living room. The store had built-in shelves along the east, west, and south walls. Walls and ceilings throughout the house were plaster over lath. Now as a result of the modernizing process in some places, there is sheet rock. The floors are all narrow wood. Doorways have simple molding; the original paneled doors have been replaced by modern doors.

Unity store sits on the south side of Damascus Road close to the street, facing north. Behind it is a lovely old maple tree near a cistern. The property does not pass county percolation tests and uses an old cistern-type waste system.

STATEMENT OF SIGNIFICANCE

This building for most of its lifetime has been used as a general store, and as such has been a focal point of the rural village of Unity.

Nimrod Davis purchased two acres of "The Resurvey on John and Sarah" in Unity in 1843 and set up his blacksmith business there.¹ Davis' daughter Lucretia married Lloyd C. Colliflower of Frederick County, and they opened their general store before 1878 in conjunction with James Harvey. After Davis' death in 1882, his heirs sold the store property to Lloyd and Lucretia Colliflower in two parcels.² Colliflower and Harvey sold "dry goods, groceries, boots, shoes, oil, paint, fish, oysters, etc.", and advertised themselves as "buyers and shippers of produce, etc."³

Lloyd Colliflower continued to operate the store after his partner sold out in 1890, but the following decade was not a prosperous one for him. He took out a \$1,500 mortgage on the store property in 1894, but could not maintain the payments and defaulted two years later. The holder of the mortgage, Charles Adler of Baltimore, attempted to sell the property, advertising it in the Montgomery Advocate as 8085 square feet:

This property fronts on the main street through said village and is nearly surrounded by the Rich farm; formerly owned by Franklin Groomes. It is improved by a two-story frame STORE HOUSE about 20 x 40 feet, stable, and other outbuildings. This is a well known and valuable business stand.

When a sale to Nathaniel Waters fell through, Adler purchased the property himself for \$1,400.⁴ He sold it three years later to Joshua Higgins and Clifford Howard, business partners.⁵

Although Howard did not remain in the business long, Higgins continued to operate it until his death in the 1920s. His widow Mary Higgins sold the property to Zachariah Windsor in 1926 who immediately sold it to Charles Zeigler;⁶ Zeigler operated the store for several years.

The Unity store was operated through the 1940s, most recently by Fletcher and Litsinger Brown, and came to the present owner in 1954. It was converted to a dwelling in the late 1940s.
