The building is one story, frame, sheathed with shiplap siding. The facade has windows flanking double doors with two-light transom. In the gable is a herringbone trim; the roof has a louvered cupola with gable roof. The foundation is stone. A semi-octogonal apse has been added in the east end; it has a semi-circular arched stained glass window.
